

## **SENATE BILL No. 1039**

May 21, 1996, Introduced by Senator GOUGEON and referred to the Committee on Judiciary.

A bill to amend section 1 of Act No. 271 of the Public Acts of 1925, entitled as amended

"An act to provide for the commitment to state institutions of certain children placed with, released to, or committed to persons, societies, organizations, associations or corporations licensed and approved by the state department of social welfare; to provide for the protection of the rights of children over whom jurisdiction is in doubt because of some question of residence, and providing for the payment of the expense thereof,"

being section 722.531 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1 of Act No. 271 of the Public Acts of
- 2 1925, being section 722.531 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. !. (1) Whenever it shall be made to appear APPEARS

- I licensed and approved by the state department of social welfare
- 2 FAMILY INDEPENDENCE AGENCY to receive, maintain, or place out for
- 3 adoption minor children or to obtain homes for dependent and
- 4 neglected children, is, by reason of mental or physical disabil-

- 25 (A) FOR COMMITMENT PROCEEDINGS COMMENCING BEFORE JANUARY 1,
- 26 1998, THE PROBATE COURT.

- (B) FOR COMMITMENT PROCEEDINGS COMMENCING ON OR AFTER
- 2 JANUARY 1, 1998, THE FAMILY DIVISION OF CIRCUIT COURT.
- 3 Section 2. This amendatory act shall not take effect unless
- 4 House Bill No. 5158 of the 88th Legislature is enacted into law.
