

SENATE BILL No. 1125

September 10, 1996, Introduced by Senator CARL and referred to the Committee on Government Operations.

A bill to amend section 6 of Act No. 451 of the Public Acts of 1976, entitled as amended

"The revised school code,"

as amended by Act No. 289 of the Public Acts of 1995, being section 380.6 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 6 of Act No. 451 of the Public Acts of
- 2 1976, as amended by Act No. 289 of the Public Acts of 1995, being
- 3 section 380.6 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 6. (1) "School district" or "local school district"
- 6 means a general powers school district organized under this act,
- 7 regardless of previous classification, or a school district of
- 8 the first class.

- 1 (2) "School elector" means a person qualified as an elector
- 2 under section 492 of the Michigan election law, Act No. 116 of
- 3 the Public Acts of 1954, being section 168.492 of the Michigan
- 4 Compiled Laws, registered as provided in part 12, and resident of
- 5 the school district, local act school district, or intermediate
- 6 school district on or before the thirtieth day before the next
- 7 ensuing annual or special school election. FOR PURPOSES OF REG-
- 8 ISTERING TO VOTE AND VOTING AT AN ELECTION, SPECIAL ELECTION, OR
- 9 PRIMARY ELECTION ON A REAL PROPERTY TAX ISSUE OR A LOCAL PROPOSAL
- 10 OR LOCAL QUESTION ONLY, A PERSON IS CONSIDERED A RESIDENT OF THE
- 11 SCHOOL DISTRICT, LOCAL ACT SCHOOL DISTRICT, OR INTERMEDIATE
- 12 SCHOOL DISTRICT TO BE AFFECTED BY THE RESULT OF THAT ELECTION IF
- 13 THAT PERSON OWNS, AND HAS PAID ALL ASSESSED AD VALOREM PROPERTY
- 14 TAXES ON, REAL PROPERTY LOCATED IN THE SCHOOL DISTRICT, LOCAL ACT
- 15 SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT.
- 16 (3) "School month" means a 4-week period of 5 days each
- 17 unless otherwise specified in the teacher's contract.
- 18 (4) "Special education building and equipment" means a
- 19 structure or portion of a structure or personal property accept-
- 20 ed, leased, purchased, or otherwise acquired, prepared, or used
- 21 for special education programs and services.
- 22 (5) "Special education personnel" means persons engaged in
- 23 and having professional responsibility for the training, care,
- 24 and education of handicapped persons in special education pro-
- 25 grams and services including, but not limited to, teachers,
- 26 aides, school social workers, diagnostic personnel, physical
- 27 therapists, occupational therapists, audiologists, teachers of

- 1 speech and language, instructional media-curriculum specialists,
- 2 mobility specialists, teacher consultants, supervisors, and
- 3 directors.
- 4 (6) "Special education programs and services" means educa-
- 5 tional and training services designed for handicappers and oper-
- 6 ated by local school districts, local act school districts,
- 7 intermediate school districts, the Michigan school for the blind,
- 8 the Michigan school for the deaf, the department of mental
- 9 health, the department of social services, or a combination
- 10 thereof, and ancillary professional services for handicappers
- 11 rendered by agencies approved by the state board. The programs
- 12 shall include vocational training, but need not include academic
- 13 programs of college or university level.
- (7) "State approved nonpublic school" means a nonpublic
- 15 school that complies with Act No. 302 of the Public Acts of 1921,
- 16 being sections 388.551 to 388.558 of the Michigan Compiled Laws.
- 17 (8) "State board" means the state board of education unless
- 18 clearly otherwise stated.
- 19 (9) "Department" means the department of education created
- 20 and operating under sections 300 to 305 of the executive organi-
- 21 zation act of 1965, Act No. 380 of the Public Acts of 1965, being
- 22 sections 16.400 to 16.405 of the Michigan Compiled Laws.
- 23 (10) "State school aid" means allotments from the general
- 24 appropriating act for the purpose of aiding in the support of the
- 25 public schools of the state.

- 1 (11) "The state school aid act of 1979" means Act No. 94 of
- 2 the Public Acts of 1979, being sections 388.1601 to 388.1772 of
- 3 the Michigan Compiled Laws.
