



# SENATE BILL No. 1126

September 10, 1996, Introduced by Senator YOUNG and referred to the Committee on Economic Development, International Trade and Regulatory Affairs.

A bill to amend section 2008 of Act No. 299 of the Public Acts of 1980, entitled as amended "Occupational code," being section 339.2008 of the Michigan Compiled Laws.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Section 2008 of Act No. 299 of the Public Acts  
2 of 1980, being section 339.2008 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4 Sec. 2008. (1) ~~A~~ IF PREPARED BY A LICENSEE AND REQUIRED  
5 TO BE SUBMITTED TO A GOVERNMENTAL AGENCY OR PUBLIC AUTHORITY FOR  
6 APPROVAL OR RECORDING, A plan, plat, drawing, map, and the title  
7 sheet of specifications, an addendum, bulletin, or report or, if  
8 a bound copy is submitted, the index sheets of a plan,  
9 specification, or report, ~~if prepared by a licensee and required~~  
10 ~~to be submitted to a governmental agency for approval or record,~~

1 shall carry the embossed or printed seal of the person in  
2 responsible charge.

3 (2) If the overlapping of the professions of architecture  
4 and engineering is involved in a project, a licensed architect or  
5 licensed professional engineer who seals the plans, drawings,  
6 specifications, and reports may perform services in the field of  
7 the other practice if the services are incidental to the archi-  
8 tectural or engineering project as a whole.

9 (3) A licensee shall not seal a plan, drawing, map, plat,  
10 report, specification, or other document not prepared by the  
11 licensee or under supervision of the licensee as the person in  
12 responsible charge.

13 (4) NOTWITHSTANDING SUBSECTION (1) AND SECTIONS 2011(1) AND  
14 2014(E), A GOVERNMENTAL AGENCY OR PUBLIC AUTHORITY SHALL NOT  
15 REJECT PLANS SUBMITTED BY A PERSON FOR ACTIVITY FOR WHICH THE  
16 PERSON IS LICENSED UNDER THE FORBES MECHANICAL CONTRACTORS ACT,  
17 ACT NO. 192 OF THE PUBLIC ACTS OF 1984, BEING SECTIONS 338.971 TO  
18 338.988 OF THE MICHIGAN COMPILED LAWS, IF THAT PERSON IS THE  
19 PERSON IN WHOSE NAME THE MECHANICAL PERMIT IS ISSUED CONCERNING  
20 THAT ACTIVITY.
