- 3 FAMILY MEMBER'S COVERAGE, ALSO PROVIDE THAT THE COVERAGE APPLICA-
- 4 BLE FOR CHILDREN SHALL BE PAYABLE WITH RESPECT TO A NEWLY BORN
- 5 CHILD OF THE SUBSCRIBER FROM THE MOMENT OF BIRTH. THE CONTRACT
- 6 MAY REQUIRE THAT NOTIFICATION OF BIRTH OF A NEWLY BORN CHILD AND
- 7 PAYMENT OF THE REQUIRED CHARGE SHALL BE FURNISHED TO THE HEALTH
- 8 MAINTENANCE ORGANIZATION WITHIN 31 DAYS AFTER THE DATE OF BIRTH
- 9 IN ORDER TO HAVE THE COVERAGE CONTINUE BEYOND THE 31-DAY PERIOD.

- (3) COVERAGE UNDER SUBSECTION (2) FOR THE ADOPTED CHILD OR 15

- 20 TIVELY AN INDIVIDUAL WHO IS ADOPTED OR WHO IS PLACED TO BE
