by amending the title and section 14a (MCL 121.14a).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

2 An act to provide for the incorporation of municipal author-
3 ities to acquire, own and operate water supply and transmission
4 systems; to provide a municipal charter therefor; ~~and~~ to pre-
5 scribe the powers and functions thereof; AND TO PRESCRIBE PENAL-
6 TIES AND PROVIDE REMEDIES.

7 Sec. 14a. (1) The resolution authorizing the issuance of
8 bonds by the authority shall be published in full in a newspaper
9 of general circulation within the corporate limits of the
10 authority within 1 week after its adoption. If, within 30 days

5 (3) The governing bodies of ~~such~~ THE cities, villages, and
6 townships ~~which~~ THAT are a part of the authority shall act as a
7 board of canvassers and shall certify the results of ~~such~~ THE
8 election to the board of commissioners of the authority within 5
9 days after the date of the election. The board of commissioners
10 of the authority within 5 days after the date of election shall
11 compile and tabulate the vote as received from the respective
12 cities, villages, and townships and certify the result of ~~such~~
13 THE election by resolution upon the records of the authority and
14 a majority of the total valid votes cast at ~~such an~~ THE elec-

20 WHO VIOLATES A PROVISION OF THE MICHIGAN ELECTION LAW, 1954 PA
21 116, MCL 168.1 TO 168.992, APPLICABLE TO A PETITION DESCRIBED IN
22 THIS SECTION IS SUBJECT TO THE PENALTIES PRESCRIBED FOR THAT VIO-
23 LATION IN THE MICHIGAN ELECTION LAW, 1954 PA 116, MCL 168.1 TO

25 Enacting section 1. This amendatory act does not take
26 effect unless House Bill No. 5138 of the 89th Legislature is
27 enacted into law.
