THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 43513. (1) A person may carry, transport, or possess a
- 2 firearm, a bow and arrow, or a crossbow without a hunting license
- 3 while at or going to and from a recognized rifle or target range,
- 4 trap, or skeet shooting ground, or archery range if the firearm
- 5 or bow and arrow or crossbow, while being carried or transported,
- 6 is as follows:
- 7 (a) The firearm is unloaded in both barrel and magazine and
- 8 either enclosed in a case or carried in the trunk of a vehicle.
- **9** (b) The bow or crossbow is unstrung, enclosed in a case, or
- 10 carried in the trunk of a vehicle.

 - (i) THE OWNER OF THE PROPERTY ON WHICH THE ACTIVITY UNDER SUBDIVISION (A)(i), (ii), OR (iii) IS TAKING PLACE.
 - (ii) THE LESSEE OF THAT PROPERTY FOR A TERM OF NOT LESS THAN 1 YEAR.
 - (C) THE OWNER OR LESSEE OF THE PROPERTY DOES NOT RECEIVE REMUNERATION FOR THE ACTIVITY UNDER SUBDIVISION (A)(i), (ii), OR (*iii*).]
