

H.B. 5346

A bill to amend 1917 PA 273, entitled  
"An act to regulate and license pawnbrokers in cities and incorporated villages of this state, having a population of more than 3,000,"  
by amending section 5 (MCL 446.205).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 5. (1) ~~Every such~~ A pawnbroker shall keep a book ~~to~~  
2 ~~be inspected by the chief of police or chief police officer of~~

14 PERMANENT RECORD OF THE TRANSACTION ON A FORM PROVIDED BY THE  
15 PAWNBROKER THAT SUBSTANTIALLY COMPLIES WITH THE FORM DESCRIBED IN  
16 SUBSECTION (4). EACH RECORD OF TRANSACTION SHALL BE COMPLETED IN  
17 QUADRUPLICATE BY THE PAWNBROKER, LEGIBLY IN INK IN THE ENGLISH  
18 LANGUAGE, AND SHALL CONTAIN ALL APPLICABLE INFORMATION REQUIRED  
19 TO COMPLETE THE RECORD OF TRANSACTION FORM UNDER SUBSECTION (4).  
[THIS SUBSECTION DOES NOT PROHIBIT THE USE AND TRANSMISSION OF THE  
INFORMATION REQUIRED IN THE RECORD OF THE TRANSACTION BY MEANS OF  
COMPUTER OR OTHER ELECTRONIC MEDIA AS PERMITTED BY THE DEPARTMENT OF  
STATE POLICE AND THE LOCAL POLICE AGENCY OR COUNTY PROSECUTING ATTORNEY  
WITHIN THE APPLICABLE LOCAL UNIT OF GOVERNMENT.]

20 (3) THE PAWNBROKER SHALL RETAIN 1 COPY OF THE RECORD OF  
21 TRANSACTION AND, WITHIN 48 HOURS AFTER THE PROPERTY IS RECEIVED,  
22 SHALL SEND 1 COPY OF THE RECORD OF TRANSACTION TO THE LOCAL  
23 POLICE AGENCY.

24 (4) THE RECORD OF TRANSACTION FORM SHALL BE 8-1/2 INCHES BY  
25 11 INCHES IN SIZE AND SHALL BE AS FOLLOWS:
