A bill to amend 1961 PA 236, entitled
"Revised judicature act of 1961,"

327.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4701. As used in this chapter:

18 (b) "Instrumentality of a crime" means any property, other
19 than real property, the use of which contributes directly and
20 materially to the commission of a crime.

21 (c) "Person" means an individual, corporation, partnership,
22 or other business entity, or an unincorporated or voluntary
23 association.

24 (d) "Proceeds of a crime" means any property obtained
25 through the commission of a crime, including any appreciation in
26 the value of the property.

1 (e) "Security interest" means any interest in real or
2 personal property that secures payment or performance of an
3 obligation.

4 (f) "Substituted proceeds of a crime" means any property
