

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 5006

A bill to amend 1986 PA 268, entitled
"Legislative council act,"
by amending section 204 (MCL 4.1204).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 204. (1) The council may provide access to computer-
2 ized council legislative ~~data bases~~ DATABASES and information
3 to individuals and organizations that are not a part of the leg-
4 islative branch of government. The council may establish rules
5 to implement this subsection. ~~-, including a system of fees and~~
6 ~~charges for access and services.~~ The council shall impose ~~such~~
7 conditions and restrictions upon nonlegislative access and serv-
8 ices as determined necessary by the council.
9 (2) The legislative computer information fund is created in
10 the state treasury and shall be administered by the council.

1 ~~The~~ MONEY FROM THE LEGISLATIVE COMPUTER INFORMATION fund shall
2 be expended only as provided in this section.

3 (3) The money received from the sale of access and related
4 services pursuant to subsection (1), along with fees charged for
5 training and the sale of user manuals and other money made avail-
6 able for ~~such~~ THESE purposes, by appropriation or otherwise,
7 shall be deposited with the state treasurer and credited to the
8 legislative computer information fund.

9 (4) The council shall utilize the legislative computer
10 information fund to pay for all of the following ~~which~~ THAT are
11 directly related to computerized council legislative ~~data bases~~
12 DATABASES and information:

13 (a) Research and development.

14 (b) Training.

15 (c) Additional hardware, software, and facilities.

16 (d) Acquisition of necessary support services.

17 (e) Editorial and compilation expenses.

18 (5) NOTWITHSTANDING SUBSECTION (1), BEGINNING JULY 1, 1999,
19 THE COUNCIL SHALL MAKE THE MICHIGAN COMPILED LAWS DATABASE SEARCH
20 AND RETRIEVAL SYSTEM AVAILABLE TO THE PUBLIC ON THE INTERNET.
21 THIS SUBSECTION DOES NOT ALTER OR RELINQUISH ANY COPYRIGHT OR
22 OTHER PROPRIETARY INTEREST OR ENTITLEMENT OF THIS STATE RELATING
23 TO ANY OF THE INFORMATION MADE AVAILABLE UNDER THIS SUBSECTION.

24 (6) BEGINNING JULY 1, 1999, THE COUNCIL SHALL NOT CHARGE A
25 FEE TO PROVIDE THE MICHIGAN COMPILED LAWS DATABASE SEARCH AND
26 RETRIEVAL SYSTEM TO THE PUBLIC ON THE INTERNET AS PROVIDED IN
27 SUBSECTION (5).
