## SENATE SUBSTITUTE FOR HOUSE BILL NO. 5216

A bill to amend 1971 PA 227, entitled

"An act to prescribe the rights and duties of parties to home solicitation sales,"

by amending section 1 (MCL 445.111), as amended by 1980 PA 108.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Home solicitation sale" means a sale of goods or serv-
- 3 ices of more than \$25.00 in which the seller or a person acting
- 4 for the seller engages in a personal, WRITTEN, or telephonic
- 5 solicitation of the sale, THE SOLICITATION IS RECEIVED BY THE
- 6 BUYER at a residence of the buyer, and the buyer's agreement or
- 7 offer to purchase is there given to the seller or a person acting
- 8 for the seller. HOME SOLICITATION SALE INCLUDES A SALE ARISING
- 9 FROM A POSTCARD OR OTHER WRITTEN NOTICE DELIVERED TO A BUYER'S
- 10 RESIDENCE THAT REQUESTS THAT THE BUYER CONTACT THE SELLER OR

- 1 SELLER'S AGENT BY TELEPHONE TO INQUIRE ABOUT A GOOD OR SERVICE,
- 2 UNLESS A POSTCARD OR OTHER WRITTEN NOTICE CONCERNS A PREVIOUS
- 3 PURCHASE OR ORDER OR SPECIFIES THE PRICE OF THE GOOD OR SERVICE
- 4 AND ACCURATELY DESCRIBES THE GOOD OR SERVICE. Home solicitation
- 5 sale does not include a sale made pursuant to a preexisting
- 6 revolving charge account, a sale made pursuant to prior negotia-
- 7 tions between the parties at a business establishment at a fixed
- 8 location where goods or services are offered or exhibited for
- 9 sale, a sale of insurance by an insurance agent licensed by the
- 10 commissioner of insurance, A SALE MADE PURSUANT TO A PRINTED
- 11 ADVERTISEMENT IN A PUBLICATION OF GENERAL CIRCULATION, or a sale
- 12 of services by a real estate broker or salesperson licensed by
- 13 the department of licensing and regulation CONSUMER AND INDUS-
- 14 TRY SERVICES. Home solicitation sale does not include a sale of
- 15 agricultural or horticultural equipment and machinery which
- 16 THAT is demonstrated to the consumer by the vendor at the request
- 17 of either or both of the parties.
- (b) "Fixed location" means a place of business where the 18
- 19 seller or an agent, servant, employee, or solicitor of that
- 20 seller primarily engages in the sale of goods or services of the
- 21 same kind as would be sold at the residence of a buyer.
- (c) "Business day" means Monday through Friday and shall 22
- 23 DOES not include Saturday, Sunday or the following business
- 24 holidays: New Year's day, Martin Luther King's birthday,
- 25 Washington's birthday, Memorial day, Independence day, Labor day,
- 26 Columbus day, Veterans' day, Thanksgiving day, and Christmas
