

**SENATE SUBSTITUTE FOR  
HOUSE BILL NO. 5233**

A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
by amending section 1277 (MCL 380.1277), as amended by 1995 PA  
289.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 1277. (1) Considering criteria established by the  
2 state board, in addition to the requirements specified in section  
3 1280 for accreditation under that section, if the board of a  
4 school district wants all of the schools of the school district  
5 to be accredited under section 1280, the board shall adopt and  
6 implement and, not later than September 1 each year, shall make  
7 available to the department a copy of a 3- to 5-year school  
8 improvement plan and continuing school improvement process for  
9 each school within the school district. The school improvement  
10 plans shall include, but are not limited to, a mission statement,

1 goals based on student academic objectives for all students,  
2 curriculum alignment corresponding with those goals, evaluation  
3 processes, staff development, development and utiliza-  
4 tion of community resources and volunteers, the role of adult and  
5 community education, libraries and community colleges in the  
6 learning community, and building level decision making. School  
7 board members, school building administrators, teachers and other  
8 school employees, pupils, parents of pupils attending that  
9 school, and other residents of the school district shall be  
10 invited and allowed to voluntarily participate in the ~~planning,~~  
11 development, ~~implementation~~ REVIEW, and evaluation of the  
12 district's school improvement plans. Upon request of the board  
13 of a school district, the department and the intermediate school  
14 district shall assist the school district in the development and  
15 implementation of district school improvement plans. Educational  
16 organizations may also provide assistance for these purposes.  
17 School improvement plans described in this section shall be  
18 updated annually by each school and by the board of the school  
19 district.

25 and intermediate school board members, school building adminis-  
26 trators, teachers and other school employees, pupils, parents of

1 district shall be invited and allowed to voluntarily participate  
2 in the ~~planning,~~ development, ~~implementation~~ REVIEW, and

4 ment plan. Upon request of the intermediate school board, the  
5 department shall assist the intermediate school district in the  
6 development and implementation of an intermediate school district  
7 school improvement plan. An intermediate school district school  
8 improvement plan described in this section shall be updated annu-  
9 ally by the intermediate school board. An intermediate school  
10 district school improvement plan shall include at least all of  
11 the following:

18 but not limited to, transportation if necessary.

21 ~~district that will lead to improved teaching and learning~~ A PLAN  
22 FOR PROFESSIONAL DEVELOPMENT THAT SUPPORTS ACADEMIC LEARNING.

23 (d) Methods to assist school districts in integrating  
24 applied academics and career and employability skills into all  
25 curricular areas.

26 (e) Ways to make available in as many fields as practicable  
27 opportunities for structured on-the-job learning, such as

3       (f) ~~Coordination of services and service delivery with  
4 other existing state and local human services agencies~~

5 COLLABORATIVE EFFORTS WITH SUPPORTING AGENCIES THAT ENHANCE ACA-  
6 DEMIC LEARNING.

7       (g) Long-range cost containment measures, including addi-  
8 tional services that might be provided at reduced costs by the  
9 intermediate school district or through cooperative programs, and  
10 cost reduction programs such as interdistrict cooperation in spe-  
11 cial education and other programs and services.

12       (h) To the extent that it would improve school effective-  
13 ness, specific recommendations on consolidation or enhanced  
14 interdistrict cooperation, or both, along with possible sources  
15 of revenue.

16       (i) ~~Identification of the role of the intermediate school  
17 district in providing services or assistance to local school  
18 districts~~ EVALUATION OF THE PLAN.

19       (4) The state board shall annually review a random sampling  
20 of school improvement plans. Based on its review, the state  
21 board shall annually submit a report on school improvement activ-  
22 ities planned and accomplished by each of the school districts  
23 and intermediate school districts that were part of the sampling  
24 to the senate and house committees that have the responsibility  
25 for education legislation.
