SUBSTITUTE FOR SENATE BILL NO. 1168

A bill to amend 1965 PA 290, entitled "Boiler act of 1965,"
(MCL 408.751 to 408.776) by adding section 7c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 7C. (1) SUBJECT TO SUBSECTIONS (2), (3), (4), AND (5),
- 2 THIS ACT DOES NOT APPLY TO A MINIATURE HOBBY LOCOMOTIVE OPERATING
- 3 ON NARROW GAUGE TRACKS LESS THAN 24 INCHES IN WIDTH.
- 4 (2) THE DEPARTMENT OF CONSUMER AND INDUSTRY SERVICES SHALL
- 5 INSPECT ANNUALLY A MINIATURE HOBBY LOCOMOTIVE OPERATING IN A
- 6 PUBLIC DISPLAY OR USE. THE INSPECTION SHALL BE CONDUCTED BY A
- 7 DEPUTY INSPECTOR OR SPECIAL INSPECTOR OR BY A MINIATURE HOBBY
- 8 LOCOMOTIVE CLUB IN THE MANNER PROVIDED FOR IN SUBSECTIONS (4) AND
- 9 (5). THE INSPECTOR SHALL FILE A COPY OF THE INSPECTION REPORT
- 10 WITH THE CHIEF INSPECTOR AND PROVIDE A COPY OF THE INSPECTION
- 11 REPORT TO THE OWNER OF THE MINIATURE HOBBY LOCOMOTIVE.

- 18 BOILERS USED IN MINIATURE HOBBY LOCOMOTIVES UPON THE BOARD'S
- 19 DETERMINATION THAT THE CLUB COMPLIES WITH AND APPLIES THE INSPEC-
- 20 TION AND CERTIFICATION STANDARDS ESTABLISHED IN THE RULES. AFTER
- 21 APPROVAL AND AUTHORIZATION BY THE BOARD, THE MINIATURE HOBBY
- 22 LOCOMOTIVE CLUB MAY INSPECT BOILERS AND CERTIFY TO THE BOARD THAT
- 23 A MINIATURE HOBBY LOCOMOTIVE COMPLIES WITH THE STANDARDS CON-
- 24 TAINED IN THE RULES.
- 25 (6) AS USED IN THIS SECTION, "PUBLIC DISPLAY OR USE" MEANS
- 26 DISPLAY TO OR USE BY THE GENERAL PUBLIC BUT NOT THE OWNER OR THE
- 27 OWNER'S FAMILY.
