- 4 FITS APPLICABLE TO CHILDREN INCLUDE BENEFITS FOR VACCINES TO
- 5 IMMUNIZE AGAINST THE DISEASES AND INFECTIONS LISTED IN SUBSECTION
- 6 (2) AND SHALL PROVIDE OR OFFER TO PROVIDE FOR COVERAGE FOR THE
- 7 ADMINISTRATION OF THE VACCINES FROM THE MOMENT OF BIRTH OR PLACE-
- 8 MENT FOR ADOPTION THROUGH THE AGE OF 36 MONTHS.
