- 1 SEC. 266. (1) FOR THE 1997 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 1997 TAX YEAR, A TAXPAYER MAY CREDIT AGAINST THE TAX IMPOSED
- 3 BY THIS ACT AN AMOUNT EQUAL TO 20% OF THE AMOUNT THE TAXPAYER
- 4 CONTRIBUTES DURING THE TAX YEAR TO AN EDUCATIONAL OR FINE ARTS
- 5 FACILITY OR ORGANIZATION.
- 6 (2) THE CREDIT ALLOWED UNDER THIS SECTION IS NOT REFUNDABLE
- 7 AND SHALL NOT EXCEED THE TAX LIABILITY OF THE TAXPAYER FOR THE
- 8 TAX YEAR.
