- 1 PART 94. OSTEOPOROSIS EDUCATION
- 2 SEC. 9401. THIS PART SHALL BE KNOWN AND MAY BE CITED AS THE

- 1 (4) AS PART OF THE PROGRAM ESTABLISHED UNDER SUBSECTION (1),
- 2 THE DEPARTMENT MAY CONDUCT A STATEWIDE NEEDS ASSESSMENT TO
- 3 IDENTIFY 1 OR MORE OF THE FOLLOWING:
- 4 (A) AVAILABLE TECHNICAL ASSISTANCE AND EDUCATIONAL MATERIALS
- 5 AND PROGRAMS NATIONWIDE.
- 6 (B) THE LEVEL OF PUBLIC AND PROFESSIONAL AWARENESS ABOUT
- 7 OSTEOPOROSIS.
- **8** (C) THE NEEDS OF OSTEOPOROSIS PATIENTS AND OF THEIR FAMILIES
- 9 AND CAREGIVERS.
- 10 (D) NEEDS OF HEALTH CARE PROVIDERS.
- 11 (E) THE SERVICES AVAILABLE TO OSTEOPOROSIS PATIENTS.
- 12 (F) EXISTENCE OF OSTEOPOROSIS TREATMENT PROGRAMS.
- (G) EXISTENCE OF OSTEOPOROSIS SUPPORT GROUPS.
- 14 (H) EXISTENCE OF OSTEOPOROSIS REHABILITATION SERVICES.
- 15 (I) NUMBER AND LOCATION OF BONE DENSITY TESTING EQUIPMENT.

- 21 SEC. 9407. (1) THERE IS APPROPRIATED FROM THE GENERAL FUND
- 22 OF THIS STATE \$250,000.00 TO THE OSTEOPOROSIS EDUCATION FUND CRE-
- 23 ATED IN SECTION 9409.
- 24 (2) THE DEPARTMENT MAY ACCEPT FROM THE STATE AND FEDERAL
- 25 GOVERNMENTS AND OTHER PUBLIC AND PRIVATE ENTITIES SERVICES AND
- 26 PROPERTY AND FUNDS FOR DEPOSIT INTO THE OSTEOPOROSIS EDUCATION
- 27 FUND CREATED IN SECTION 9409.

- 1 (3) THE DEPARTMENT SHALL SEEK A FEDERAL WAIVER OR WAIVERS
- 2 NECESSARY TO MAXIMIZE FUNDS FROM THE FEDERAL GOVERNMENT TO IMPLE-
- 3 MENT THE OSTEOPOROSIS PREVENTION AND TREATMENT EDUCATION PROGRAM.
- 4 SEC. 9409. (1) THE OSTEOPOROSIS EDUCATION FUND IS CREATED
- 5 IN THE STATE TREASURY. THE DEPARTMENT SHALL EXPEND THE FUND ONLY
- 6 TO CARRY OUT ITS DUTIES UNDER THIS PART.
- 7 (2) THE STATE TREASURER SHALL DEPOSIT IN THE FUND ALL MONEY
- 8 RECEIVED BY THE DEPARTMENT UNDER SECTION 9407 AND ALL MONEY
- 9 RECEIVED BY THE FUND AS OTHERWISE PROVIDED BY LAW.
- 10 (3) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 11 FUND. INTEREST AND EARNINGS OF THE FUND SHALL BE CREDITED TO THE
- 12 FUND. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 13 REMAIN IN THE FUND AND SHALL NOT REVERT TO THE GENERAL FUND.
