- 1 SEC. 803Q. (1) A PERSON WHO HAS SERVED AS A VOLUNTEER, VOL-
- 2 UNTEER LEADER, OR EMPLOYEE IN THE PEACE CORPS UNDER SECTIONS 5 TO
- 3 7 OF TITLE I OF PUBLIC LAW 87-293, 22 U.S.C. 2504 TO 2506, MAY
- 4 APPLY TO THE SECRETARY OF STATE FOR A SPECIAL REGISTRATION PLATE,
- 5 WHICH SHALL DISPLAY AN APPROPRIATE VIGNETTE PRECEDING THE REGIS-
- 6 TRATION NUMBERS AND SHALL HAVE THE WORDS "PEACE CORPS" INSCRIBED
- 7 BENEATH THE REGISTRATION NUMBERS.
- 8 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 9 A FORM PRESCRIBED BY THE SECRETARY OF STATE AND SHALL BE
