## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3C. (1) A PERSON WHO PROVIDES AN INDIVIDUAL RESIDING
- 2 IN THIS STATE WITH A WRITTEN SOLICITATION THAT IDENTIFIES THE
- 3 INDIVIDUAL AS THE WINNER OF A SWEEPSTAKES OR CONTEST SHALL
- 4 INCLUDE ON THE FIRST PAGE OF THE WRITTEN SOLICITATION A NOTICE
- 5 CONTAINING ALL OF THE FOLLOWING IN NOT LESS THAN 14-POINT TYPE:
- 6 (A) THE FOLLOWING STATEMENT IN THE FOLLOWING FORM: "THIS IS
- 7 NOT A PRIZE OR A NOTICE OF A PRIZE. YOU HAVE NOT WON ANYTHING
- 8 UNLESS YOU COMPLY WITH THE CONDITIONS DESCRIBED IN THIS
- 9 DOCUMENT.".
- 10 (B) A STATEMENT THAT IDENTIFIES WITH SPECIFICITY EACH
- 11 CONDITION REQUIRED TO BE MET BEFORE THE INDIVIDUAL MAY RECEIVE

- 10 (3) A PERSON WHO PROVIDES AN INDIVIDUAL RESIDING IN THIS
- 11 STATE WITH AN ORAL SOLICITATION DESCRIBED IN SUBSECTION (1) SHALL
- 12 DO BOTH OF THE FOLLOWING:
- 13 (A) AT THE TIME OF THE SOLICITATION, ORALLY PROVIDE THE
- 14 INDIVIDUAL WITH THE STATEMENTS DESCRIBED IN SUBSECTION (1).
- 15 (B) WITHIN 1 BUSINESS DAY AFTER THE DATE OF THE SOLICITA-
- 16 TION, PROVIDE THE INDIVIDUAL WITH THE WRITTEN NOTICE DESCRIBED IN
- 17 SUBSECTION (1).
- 18 (4) AS USED IN THIS SECTION, "SOLICITATION" MEANS AN OFFER
- 19 TO SELL OR LEASE A GOOD OR SERVICE BY EXPRESSLY OR BY IMPLICATION
- 20 REPRESENTING THAT THE OFFER IS AN ELEMENT OF A SWEEPSTAKES OR
- **21** CONTEST.
