A bill to amend 1996 PA 354, entitled
"Savings bank act,"
(MCL 487.3101 to 487.3804) by adding section 513.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 513. (1) AS USED IN THIS SECTION:
- 2 (A) "ATM" MEANS AN AUTOMATIC TELLER MACHINE OR OTHER DEVICE
- 3 THAT PERMITS A PERSON TO ELECTRONICALLY TRANSACT BUSINESS WITH
- 4 HIS OR HER FINANCIAL INSTITUTION.
- 5 (B) "FINANCIAL INSTITUTION" MEANS A STATE OR NATIONALLY
- 6 CHARTERED BANK OR A STATE OR FEDERALLY CHARTERED SAVINGS AND LOAN
- 7 ASSOCIATION, SAVINGS BANK, OR CREDIT UNION.
- 8 (2) IF A SAVINGS BANK ASSESSES OR IMPOSES A FEE OR CHARGE
- 9 FOR THE USE OF AN ATM OF THE SAVINGS BANK, PRIOR TO THE
- 10 COMPLETION OF THE ATM TRANSACTION, THE SAVINGS BANK SHALL NOTIFY

1 THE PERSON USING THE ATM OF THE FEE OR CHARGE AND THE AMOUNT THAT
2 WILL BE ASSESSED OR IMPOSED.

3 (3) IF THE PERSON ATTEMPTING TO USE THE SAVINGS BANK'S ATM
4 IS ACCESSING AN ACCOUNT IN ANOTHER FINANCIAL INSTITUTION, THEN IN
5 ADDITION TO THE INFORMATION REQUIRED TO BE DISCLOSED UNDER SUB-
6 SECTION (1), THE SAVINGS BANK SHALL ALSO NOTIFY THE PERSON THAT
7 HIS OR HER FINANCIAL INSTITUTION MAY ASSESS OR IMPOSE AN ADDI-
8 TIONAL FEE OR CHARGE.

9 (4) THE PERSON ATTEMPTING TO USE THE SAVINGS BANK'S ATM
10 SHALL BE ABLE TO CANCEL THE TRANSACTION AT ANY TIME WITHOUT
11 INCURRING A FEE OR CHARGE.
