Enacting section 1. This amendatory act does not take 13 14 effect unless the United States department of health and human 15 services grants part 3 of the family independence agency's waiver 16 filed under the child welfare demonstration project to permit a 17 transfer of title IV-E funding from the state to 1 or more coun-18 ties and the family independence agency files with the secretary 19 of state a certification that the necessary waiver was granted.
