## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 502D. (1) A PERSON WHO MANUFACTURES OR DISTRIBUTES IN
- 2 THIS STATE OR CAUSES TO BE MANUFACTURED OR DISTRIBUTED IN THIS
- 3 STATE AN UNNECESSARILY HAZARDOUS PRODUCT OR DEVICE IS GUILTY OF A
- 4 CRIME AS PROVIDED IN SUBSECTION (3) IF THE PRODUCT OR DEVICE
- 5 INJURES ANOTHER PERSON OR CAUSES THE DEATH OF ANOTHER PERSON AND
- 6 EITHER OF THE FOLLOWING CIRCUMSTANCES EXISTS:
- 7 (A) THE PERSON WHO MANUFACTURED OR DISTRIBUTED THE PRODUCT
- 8 OR DEVICE OR CAUSED THE PRODUCT OR DEVICE TO BE MANUFACTURED MADE
- 9 A FALSE OR MISLEADING CLAIM ABOUT THE SAFETY OF THE PRODUCT.
- 10 (B) THE PERSON WHO MANUFACTURED OR DISTRIBUTED THE PRODUCT
- 11 OR DEVICE OR CAUSED THE PRODUCT OR DEVICE TO BE MANUFACTURED

- 1 CONCEALED RESEARCH, DATA, STUDIES, OR OTHER INFORMATION

- 4 (2) A PERSON WHO MANUFACTURES OR DISTRIBUTES IN THIS STATE

- 14 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY
- 15 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF
- 16 NOT MORE THAN \$1,000,000.00, OR BOTH.
- 17 (4) AS USED IN THIS SECTION, "PERSON" MEANS AN INDIVIDUAL
- 18 HAVING FULL OR PARTIAL AUTHORITY IN A BUSINESS TO PREVENT THE
- 19 MANUFACTURE OR DISTRIBUTION OF A PRODUCT OR DEVICE OR TO REQUIRE
- 20 THE RECALL OF A PRODUCT OR DEVICE.
