## **HOUSE BILL No. 5401**

December 3, 1997, Introduced by Reps. A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 11527 (MCL 324.11527) and by adding sections 11527a, 11527b, 11527c, 11527d, 11532a, and 11551.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11527. (1) A solid waste hauler transporting solid
- 2 waste over a public road in this state shall deliver all waste to
- 3 a disposal area or solid waste transfer facility licensed under
- 4 this part and shall use only a vehicle or container that does not
- 5 contribute to littering and that conforms to the rules promul-
- 6 gated by the department.
- 7 (2) EACH SOLID WASTE TRANSPORTING UNIT USED FOR THE TRANS-
- 8 PORT OF SOLID WASTE SHALL CONTAIN A DECAL AS PRESCRIBED BY THE
- 9 DEPARTMENT CLEARLY IDENTIFYING IT AS A SOLID WASTE TRANSPORTING
- **10** UNIT.

- 1 (3)  $\overline{(2)}$  A solid waste hauler who violates this part or a
- 2 rule promulgated under this part, or who is responsible for a
- 3 vehicle that has in part contributed to a violation of this part
- 4 or a rule promulgated under this part, is subject to a penalty as

- 6 SEC. 11527A. (1) A PERSON SHALL NOT ENGAGE IN BUSINESS
- 7 WITHIN THIS STATE AS A SOLID WASTE HAULER WITHOUT OBTAINING A
- 8 SOLID WASTE HAULER BUSINESS LICENSE FROM THE DEPARTMENT.
- 9 ADDITIONALLY, EACH SOLID WASTE TRANSPORTING UNIT USED TO TRANS-
- 10 PORT SOLID WASTE OFF SITE SHALL BE LICENSED UNDER THIS PART. AN
- 11 APPLICATION FOR A SOLID WASTE HAULER BUSINESS LICENSE OR A SOLID
- 12 WASTE TRANSPORTING UNIT LICENSE SHALL BE MADE ON A FORM PROVIDED
- 13 BY THE DEPARTMENT.
- 14 (2) AN APPLICATION FOR A SOLID WASTE HAULER BUSINESS LICENSE
- 15 SHALL BE ACCOMPANIED BY THE FOLLOWING:
- 16 (A) A BUSINESS LICENSE APPLICATION FEE OF \$200.00.
- 17 (B) A SOLID WASTE TRANSPORTING UNIT LICENSE APPLICATION FEE
- 18 OF \$30.00 FOR EACH SOLID WASTE TRANSPORTING UNIT USED BY THE
- 19 SOLID WASTE HAULER TO TRANSPORT OR CARRY SOLID WASTE.
- 20 (C) A BOND IN THE AMOUNT OF \$75.00 FOR EACH TON OF SOLID
- 21 WASTE PROJECTED TO BE TRANSPORTED BY THE SOLID WASTE HAULER AS
- 22 DETERMINED BY THE DEPARTMENT DURING THE TERM OF THE LICENSE.
- 23 (3) THE BUSINESS LICENSE APPLICATION FEE AND THE SOLID WASTE
- 24 TRANSPORTING UNIT LICENSE APPLICATION FEE SHALL BE REFUNDED IF
- 25 THE APPLICATION IS DENIED BY THE DEPARTMENT.
- 26 SEC. 11527B. UPON SUBMISSION OF THE SOLID WASTE HAULER
- 27 BUSINESS LICENSE APPLICATION, THE DEPARTMENT SHALL EXAMINE THE

- 1 APPLICATION TO ENSURE THAT IT IS COMPLETE AND SHALL CONDUCT AN
- 2 INSPECTION TO VERIFY THAT THE EQUIPMENT, LOCATION, AND METHODS OF
- 3 THE APPLICANT ARE ADEQUATE TO PROVIDE SOLID WASTE TRANSPORT SERV-
- 4 ICES UNDER THIS PART AND THE RULES PROMULGATED UNDER THIS PART.
- 5 THE DEPARTMENT SHALL ESTABLISH, BY RULE, THE INSPECTION STANDARDS
- 6 AND REQUIREMENTS. UPON APPROVAL OF THE APPLICATION, THE DEPART-
- 7 MENT SHALL ISSUE A BUSINESS LICENSE AND A SOLID WASTE TRANSPORT-
- 8 ING UNIT LICENSE FOR EACH SOLID WASTE TRANSPORTING UNIT OPERATED
- 9 BY THE SOLID WASTE HAULER. A BUSINESS LICENSE OR A SOLID WASTE
- 10 TRANSPORTING UNIT LICENSE IS NOT TRANSFERABLE FROM A BUSINESS OR
- 11 SOLID WASTE TRANSPORTING UNIT TO ANOTHER BUSINESS OR SOLID WASTE
- 12 TRANSPORTING UNIT. A SOLID WASTE TRANSPORTING UNIT USED TO
- 13 TRANSPORT OR CARRY SOLID WASTE SHALL CARRY A LICENSE FROM THE
- 14 DEPARTMENT THAT MAY BE INSPECTED BY THE DEPARTMENT, AN AUTHORIZED
- 15 REPRESENTATIVE OF THE DEPARTMENT, OR A PEACE OFFICER.
- 16 SEC. 11527C. (1) A LICENSE ISSUED PURSUANT TO SECTION
- 17 11527B EXPIRES 2 YEARS AFTER THE DATE OF ISSUANCE. AN APPLICA-
- 18 TION FOR RENEWAL OF A LICENSE SHALL BE SUBMITTED AT LEAST 60 DAYS
- 19 BEFORE EXPIRATION OF THE LICENSE.
- 20 (2) THE DEPARTMENT SHALL REVOKE A SOLID WASTE HAULER BUSI-
- 21 NESS LICENSE ISSUED UNDER THIS PART IF THE DEPARTMENT DETERMINES,
- 22 AFTER PROVIDING AN OPPORTUNITY FOR A CONTESTED CASE HEARING PUR-
- 23 SUANT TO THE ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306,
- 24 MCL 24.201 TO 24.328, THAT THE HOLDER OF THE LICENSE DISPOSES OF
- 25 SOLID WASTE AT A SOLID WASTE DISPOSAL AREA THAT IS NOT IN COMPLI-
- 26 ANCE WITH THIS PART OR THE RULES PROMULGATED UNDER THIS PART OR

- 1 USES A SOLID WASTE TRANSPORTING UNIT CONTRARY TO THIS PART OR THE
- 2 RULES PROMULGATED UNDER THIS PART.
- 3 SEC. 11527D. (1) THE DEPARTMENT, BY RULE, SHALL ESTABLISH
- 4 AND IMPLEMENT A MANIFEST SYSTEM TO IDENTIFY THE QUANTITY, COMPO-
- 5 SITION, ORIGIN, ROUTING, AND DESTINATION OF DURABLE GOODS DURING
- 6 THEIR TRANSPORTATION FROM THE POINT THE DURABLE GOODS BECOME
- 7 SOLID WASTE TO THE POINT OF THEIR DISPOSAL.
- 8 (2) AS USED IN THIS SECTION, "DURABLE GOODS" MEANS ITEMS, AS
- 9 IDENTIFIED BY RULE, THAT ARE OF A SIZE AND NATURE THAT ARE GENER-
- 10 ALLY PICKED UP AND DISPOSED OF SEPARATELY FROM RESIDENTIALLY GEN-
- 11 ERATED SOLID WASTE SUCH AS APPLIANCES, FURNITURE, CARPETS AND
- 12 RUGS, TIRES, LEAD ACID BATTERIES, AND OTHER OVERSIZED AND BULKY
- 13 DURABLE ITEMS.
- 14 SEC. 11532A. (1) THERE IS IMPOSED UPON EACH CUBIC YARD OF
- 15 SOLID WASTE AND MUNICIPAL SOLID WASTE INCINERATOR ASH DISPOSED OF
- 16 IN A LANDFILL IN THIS STATE A SOLID WASTE ENFORCEMENT REGULATORY
- 17 FEE OF 8 CENTS. THE SOLID WASTE ENFORCEMENT REGULATORY FEES
- 18 IMPOSED UNDER THIS SECTION SHALL BE COLLECTED BY THE OWNERS OR
- 19 OPERATORS OF THE LANDFILLS AND SHALL BE FORWARDED TO THE DEPART-
- 20 MENT IN THE MANNER AND ALONG WITH ANY SUPPORTING DOCUMENTATION
- 21 REQUIRED BY THE DEPARTMENT.
- 22 (2) THE DEPARTMENT SHALL FORWARD SOLID WASTE ENFORCEMENT
- 23 REGULATORY FEES COLLECTED UNDER THIS SECTION TO THE STATE TREA-
- 24 SURER FOR DEPOSIT IN THE SOLID WASTE ENFORCEMENT FUND CREATED IN
- **25** SECTION 11551.
- 26 SEC. 11551. (1) THE SOLID WASTE ENFORCEMENT FUND IS CREATED
- 27 WITHIN THE STATE TREASURY.

- 1 (2) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
- 2 FROM ANY SOURCE FOR DEPOSIT INTO THE SOLID WASTE ENFORCEMENT
- 3 FUND. THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 4 SOLID WASTE ENFORCEMENT FUND. THE STATE TREASURER SHALL CREDIT
- 5 TO THE SOLID WASTE ENFORCEMENT FUND INTEREST AND EARNINGS FROM
- 6 FUND INVESTMENTS.
- 7 (3) MONEY IN THE SOLID WASTE ENFORCEMENT FUND AT THE CLOSE
- 8 OF THE FISCAL YEAR SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE
- 9 TO THE GENERAL FUND.
- 10 (4) THE DEPARTMENT SHALL EXPEND MONEY FROM THE SOLID WASTE
- 11 ENFORCEMENT FUND, UPON APPROPRIATION, ONLY FOR THE ENFORCEMENT OF
- 12 THIS PART. IT IS THE INTENT OF THE LEGISLATURE THAT THE DEPART-
- 13 MENT EXPEND MONEY IN THE SOLID WASTE ENFORCEMENT FUND TO EMPLOY
