## **HOUSE BILL No. 5754**

April 22, 1998, Introduced by Rep. Nye and referred to the Committee on Agriculture.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 802 (MCL 257.802), as amended by 1997 PA 80.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 802. (1) For a special registration issued as provided
- 2 for in section 226(8), there shall be paid 1/2 the tax imposed
- 3 under section 801 and in addition a fee of \$10.00. The fee shall
- 4 be credited to the Michigan transportation fund and used to
- 5 defray the expenses of the special registration.
- **6** (2) For all commercial vehicles registered after August 31
- 7 for the period expiring the last day of February and all motorcy-
- 8 cles registered after September 30 for the period expiring on the
- 9 last day of March, a tax of 1/2 the rate otherwise imposed by
- 10 this act shall be collected. This subsection is not applicable

- 3 (3) For each special registration as provided for in section
- 4 226(9), a fee of \$10.00 shall be collected. The fee shall be
- 5 credited to the Michigan transportation fund and used to defray
- 6 the expenses of the special registrations.
- 7 (4) For temporary registration plates or markers as provided
- **8** for in section 226a(1), a fee of \$5.00 for each group of 5 of
- 9 those temporary registration plates or markers shall be
- 10 collected. The fee shall be credited to the Michigan transporta-
- 11 tion fund and used to defray the expenses of the temporary regis-

- 18 fund and used to defray the expenses of the special registration
- 19 program. The special registration shall be valid for a period of
- 20 up to 12 months and shall expire on December 31.
- 21 (10) The secretary of state, upon request, may issue a spe-
- 22 cial registration valid for 3 or more months for a road tractor,
- 23 truck, or truck tractor owned by a farmer, if the motor vehicle
- 24 is used exclusively in connection with the farmer's farming oper-
- 25 ations or for the transportation of the farmer and the farmer's
- 26 family and not used for hire. The fee for the registration shall
- 27 be 1/10 of the fee provided in section 801(1)(c) times the number

- 1 of months for which the special registration is requested and, in
- 2 addition, a service fee of \$10.00. The fee shall be credited to
- 3 the Michigan transportation fund and used to defray the expenses
- 4 of the registration. No special registration shall be issued for
- 5 a motor vehicle for which the fee under section 801(1)(c) would
- 6 be less than \$50.00.
- 7 (11) The secretary of state, upon request, may issue a reg-
- 8 istration valid for 3 months or more for use on a vehicle with an
- 9 elected gross weight of 24,000 pounds or greater. The fee for
- 10 the registration shall be 1/12 of the fee provided in
- 11 section 801(1)(k), times the number of months for which the spe-
- 12 cial registration is requested and, in addition, a service fee of
- 13 \$10.00. The fee shall be credited to the Michigan transportation
- 14 fund and used to defray the expenses of the registration.
