

# HOUSE BILL No. 5813

April 30, 1998, Introduced by Reps. DeVuyst, Baird, Voorhees, Gernaat, Horton, Dalman, Jellema, Hammerstrom, Brater, Birkholz, LaForge, Richner, Green, Jansen, McBryde, Middleton, Jelinek, Sikkema, Middaugh, Byl, Llewellyn and Perricone and referred to the Committee on Conservation, Environment and Recreation.

A bill to amend 1994 PA 451, entitled  
"Natural resources and environmental protection act,"  
(MCL 324.101 to 324.90106) by adding sections 80186a, 81140a, and  
82147a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1        SEC. 80186A. THE COURT OR THE SECRETARY OF STATE THAT  
2 ORDERS THE OPERATOR'S OR CHAUFFEUR'S LICENSE OF A PERSON SUS-  
3 PENDED OR REVOKED UNDER SECTION 319(4), 320(2), OR 625B(6) OF THE  
4 MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.319, 257.320, AND  
5 257.625B, SHALL ALSO ORDER THE PERSON NOT TO OPERATE A VESSEL  
6 UNDER THIS PART FOR THE SAME PERIOD.

7        SEC. 81140A. THE COURT OR THE SECRETARY OF STATE THAT  
8 ORDERS THE OPERATOR'S OR CHAUFFEUR'S LICENSE OF A PERSON  
9 SUSPENDED OR REVOKED UNDER SECTION 319(4), 320(2), OR 625B(6) OF  
10 THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.319, 257.320, AND

1 257.625B, SHALL ALSO ORDER THE PERSON NOT TO OPERATE AN ORV UNDER  
2 THIS PART FOR THE SAME PERIOD.

3 SEC. 82147A. THE COURT OR SECRETARY OF STATE THAT ORDERS  
4 THE OPERATOR'S OR CHAUFFEUR'S LICENSE OF A PERSON SUSPENDED OR  
5 REVOKED UNDER SECTION 319(4), 320(2), OR 625B(6) OF THE MICHIGAN  
6 VEHICLE CODE, 1949 PA 300, MCL 257.319, 257.320, AND 257.625B,  
7 SHALL ALSO ORDER THE PERSON NOT TO OPERATE A SNOWMOBILE UNDER  
8 THIS PART FOR THE SAME PERIOD.
