## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 438. (1) FOR THE 1999 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 1999 TAX YEAR, A TAXPAYER MAY DESIGNATE ON HIS OR HER ANNUAL
- 3 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND
- 4 BE CREDITED TO THE GREAT LAKES ENDOWMENT FUND CREATED IN THE
- 5 GREAT LAKES ENDOWMENT FUND ACT. IF A TAXPAYER'S REFUND IS NOT
- 6 SUFFICIENT TO MAKE A CONTRIBUTION UNDER THIS SECTION, THE TAX-
- 7 PAYER MAY DESIGNATE A CONTRIBUTION AMOUNT AND THAT CONTRIBUTION
- 8 AMOUNT SHALL BE ADDED TO THE TAXPAYER'S TAX LIABILITY FOR THE TAX
