- **7** SECTION 24(7).
- 8 (2) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A COMMIT-
- 9 TEE REQUIRED TO BE DISSOLVED SHALL NOT MAKE A CONTRIBUTION OR
- 10 EXPENDITURE ON OR AFTER THE EFFECTIVE DATE OF THIS SECTION. A

- 12 GIVEN TO A HOUSE POLITICAL PARTY CAUCUS COMMITTEE.
- 13 (E) IF THE PERSON HOLDS THE OFFICE OF STATE SENATOR, GIVEN
- 14 TO A SENATE POLITICAL PARTY CAUCUS COMMITTEE.
- 15 (F) GIVEN TO ANOTHER INDEPENDENT COMMITTEE.
- 16 (G) GIVEN TO A BALLOT QUESTION COMMITTEE.
- 17 (3) A PERSON WHO KNOWINGLY VIOLATES THIS SECTION IS GUILTY
- 18 OF A MISDEMEANOR, PUNISHABLE BY A FINE OF NOT MORE THAN \$1,000.00
- 19 OR IMPRISONMENT FOR NOT MORE THAN 90 DAYS, OR BOTH.
