## SENATE BILL NO. 573

June 5, 1997, Introduced by Senators BOUCHARD, GEAKE and SHUGARS and referred to the Committee on Gaming and Casino Oversight.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding sections 309a and 309b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 309A. (1) A PERSON SHALL NOT KNOWINGLY CONDUCT OR
- 2 ALLOW GAMBLING ON A WATERCRAFT ON WATERS WITHIN THE JURISDICTION
- 3 OF THIS STATE DURING AN EXCURSION THAT BOTH EMBARKS AND DISEM-
- 4 BARKS AT A POINT WITHIN THIS STATE.
- 5 (2) AS USED IN THIS SECTION, "WATERCRAFT" MEANS ANY CONTRIV-
- 6 ANCE USED OR DESIGNED FOR NAVIGATION ON WATER.
- 7 (3) A PERSON WHO VIOLATES THIS ACT IS GUILTY OF A FELONY
- 8 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5 YEARS, A FINE OF
- **9** \$5,000.00, OR BOTH.
- 10 SEC. 309B. (1) A PERSON SHALL NOT DO EITHER OF THE

- 1 (A) OFFER ON-LINE GAMBLING TO RESIDENTS OF THIS STATE.
- 2 (B) TRANSMIT MONEY OR CREDIT TO A RESIDENT OF THIS STATE AS
- 3 A RESULT OF AN ON-LINE GAMBLING TRANSACTION.
- 4 (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY
- 5 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS, A FINE OF
- 6 NOT MORE THAN \$10,000.00, OR BOTH.
- 7 (3) AS USED IN THIS SECTION:
- 8 (A) "COMPUTER" MEANS AN ELECTRONIC DATA PROCESSING SYSTEM,
- 9 COMPOSED OF 1 OR MORE COMPONENTS, THAT UTILIZES STORAGE AND PRO-
- 10 CESSING MECHANIZATION AND HAS A DIRECT AUTOMATIC MEANS OF INPUT
- 11 AND OUTPUT, INCLUDING, BUT NOT LIMITED TO, CENTRAL PROCESSING
- 12 UNITS, DATA INPUT/OUTPUT CHANNELS, MAIN STORAGE OR MEMORY, AND
- 13 PERIPHERAL DEVICES FOR SYSTEMS CONTROL, DATA INPUT, OUTPUT, OR
- 14 TEMPORARY OR PERMANENT STORAGE OF INFORMATION, AND ASSOCIATED
- 15 REUSABLE MEDIA REQUIRED BY THESE DEVICES AND OPERATING SYSTEMS
- 16 SOFTWARE.
- 17 (B) "ON-LINE GAMBLING" MEANS THE MAKING, PLACING, OR RECEIPT
- 18 VIA COMPUTER OF ANY WAGER OF MONEY OR OTHER THING OF VALUE, MADE
- 19 IN EXCHANGE FOR A CHANCE TO WIN A PRIZE, STAKE, OR OTHER CONSID-
- 20 ERATION OR THING OF VALUE, DEPENDENT UPON THE RESULT OF ANY GAME,
- 21 CONTEST, OR ANY OTHER EVENT THE OUTCOME OF WHICH IS UNCERTAIN,
- 22 WHETHER THE GAME, CONTEST, OR OTHER EVENT OCCURS INSIDE OR OUT-
- 23 SIDE OF THIS STATE.
- 24 (C) "PERSON" MEAN AN INDIVIDUAL, CORPORATION, LIMITED
- 25 LIABILITY COMPANY, PARTNERSHIP, FIRM, ORGANIZATION, ASSOCIATION,
- 26 GOVERNMENTAL ENTITY, OR OTHER LEGAL ENTITY.
