A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 795.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 SEC. 79501. AS USED IN THIS PART:
- 3 (A) "COMMISSION" MEANS THE MICHIGAN JOBS COMMISSION.
- 4 (B) "DEPARTMENT" MEANS THE DEPARTMENT OF ENVIRONMENTAL
- 5 QUALITY.
- 6 (C) "GRANT" MEANS A WATERFRONT REDEVELOPMENT GRANT UNDER
- 7 THIS PART.
- 8 (D) "RESPONSE ACTIVITY" MEANS THAT TERM AS IT IS DEFINED IN
- 9 PART 201.
- 10 (E) "WATERFRONT" MEANS LAND THAT IS CONTIGUOUS TO ANY OF THE
- 11 FOLLOWING:

- 1 (i) THE GREAT LAKES OR THEIR CONNECTING WATERWAYS.
- 2 (ii) A LAKE, POND, OR IMPOUNDMENT THAT HAS A SURFACE AREA OF
- 3 NOT LESS THAN 5 ACRES.
- 4 (iii) A RIVER, STREAM, OR CREEK THAT MAY OR MAY NOT BE SERV-
- 5 ING AS A DRAIN AS DEFINED BY THE DRAIN CODE OF 1956, 1956 PA 40,
- 6 MCL 280.1 TO 280.630.
- 7 (iv) ANY OTHER BODY OF WATER OF NOT LESS THAN 5 ACRES OF

- 13 (G) "WATERFRONT PLANNING AREA" MEANS THE GEOGRAPHIC AREA
- 14 INCLUDED WITHIN A WATERFRONT REDEVELOPMENT PLAN.
- 15 SEC. 79502. (1) THE DEPARTMENT SHALL ESTABLISH A WATERFRONT
- 16 REDEVELOPMENT GRANT PROGRAM. A LOCAL UNIT OF GOVERNMENT MAY
- 17 APPLY TO THE DEPARTMENT FOR A GRANT TO CONDUCT A PROJECT THAT
- 18 DOES ANY OF THE FOLLOWING:
- 19 (A) PROVIDES FOR RESPONSE ACTIVITIES ON WATERFRONT PROPERTY
- 20 CONSISTENT WITH A WATERFRONT REDEVELOPMENT PLAN.
- 21 (B) PROVIDES FOR THE DEMOLITION OF BUILDINGS AND OTHER
- 22 FACILITIES ALONG A WATERFRONT THAT ARE INCONSISTENT WITH A WATER-

- 24 (C) PROVIDES FOR THE ACQUISITION OF WATERFRONT PROPERTY OR
- 25 THE ASSEMBLY OF WATERFRONT PROPERTY CONSISTENT WITH A WATERFRONT
- 26 REDEVELOPMENT PLAN.

- 1 (D) PROVIDES PUBLIC INFRASTRUCTURE AND PUBLIC FACILITY
- 2 IMPROVEMENTS TO WATERFRONT PROPERTY CONSISTENT WITH A WATERFRONT
- 3 REDEVELOPMENT PLAN.
- 4 (2) FOR ANY GRANT ISSUED UNDER THIS PART, THE DEPARTMENT
- 5 SHALL REQUIRE THAT A LOCAL UNIT OF GOVERNMENT PROVIDE AT LEAST
- 6 25% OF THE TOTAL PROJECT'S COST FROM OTHER PUBLIC OR PRIVATE
- 7 FUNDING SOURCES.
- 8 SEC. 79503. A LOCAL UNIT OF GOVERNMENT THAT DESIRES TO
- 9 APPLY FOR A GRANT SHALL PREPARE A WATERFRONT REDEVELOPMENT PLAN
- 10 THAT PROVIDES FOR THE IMPROVEMENT OF THE WATERFRONT. THE WATER-
- 11 FRONT REDEVELOPMENT PLAN, AT A MINIMUM, SHALL DO BOTH OF THE
- 12 FOLLOWING:
- 13 (A) CLEARLY DESIGNATE THE GEOGRAPHIC AREA INCLUDED WITHIN
- 14 THE WATERFRONT PLANNING AREA.
- 15 (B) IDENTIFY THE ECONOMIC IMPACT ON THE IMPROVED AREA, THE
- 16 SURROUNDING NEIGHBORHOOD, AND THE REGION IN WHICH THE WATERFRONT
- 17 PLANNING AREA IS LOCATED.
- 18 SEC. 79504. A LOCAL UNIT OF GOVERNMENT THAT WISHES TO BE
- 19 CONSIDERED FOR A GRANT SHALL SUBMIT A GRANT APPLICATION TO THE
- 20 DEPARTMENT IN A MANNER PRESCRIBED BY THE DEPARTMENT AND CONTAIN-
- 21 ING THE INFORMATION REQUIRED BY THE DEPARTMENT. THE GRANT APPLI-
- 22 CATION SHALL ALSO INCLUDE ALL OF THE FOLLOWING:
- 23 (A) A DETAILED DESCRIPTION OF THE PROJECT AND HOW THE GRANT
- 24 WOULD BE USED, INCLUDING ANY PRIVATE SECTOR PARTICIPATION.
- 25 (B) A COPY OF THE WATERFRONT REDEVELOPMENT PLAN FOR THE AREA
- 26 IN WHICH THE PROJECT IS TO BE LOCATED.

- 1 (C) A DISCUSSION OF HOW THE PROJECT WILL CONTRIBUTE
- 2 SIGNIFICANTLY TO THE LOCAL UNIT OF GOVERNMENT'S ECONOMIC AND
- 3 COMMUNITY REDEVELOPMENT OR THE REVITALIZATION OF ADJACENT
- 4 NEIGHBORHOODS.
- 5 (D) AN EXPLANATION OF HOW THE PROJECT WILL PROVIDE FOR
- 6 PUBLIC ACCESS TO THE WATERFRONT OR WILL PROVIDE RECREATIONAL
- 7 OPPORTUNITIES FOR THE PUBLIC.
- 8 (E) IF THE PROJECT INCLUDES THE PURCHASE OF PROPERTY, AN
- 9 IDENTIFICATION OF THE INTENDED USE OF THE PROPERTY, AND A TIME-
- 10 LINE FOR REDEVELOPMENT OF THE PROPERTY.
- 11 (F) THE TOTAL COST OF THE PROJECT AND THE SOURCE OF THE
- 12 LOCAL UNIT OF GOVERNMENT'S CONTRIBUTION TO THE PROJECT.
- 13 (G) OTHER INFORMATION THAT THE DEPARTMENT AND THE COMMISSION
- 14 CONSIDER RELEVANT.
- 15 SEC. 79505. UPON RECEIPT OF A GRANT APPLICATION UNDER SEC-
- 16 TION 79504, THE DEPARTMENT SHALL FORWARD A COPY OF THE APPLICA-
- 17 TION TO THE COMMISSION. THE DEPARTMENT AND THE COMMISSION SHALL
- 18 JOINTLY REVIEW THE GRANT APPLICATIONS. IN REVIEWING GRANT APPLI-
- 19 CATIONS, THE DEPARTMENT AND THE COMMISSION SHALL CONSIDER ALL OF
- 20 THE FOLLOWING:
- 21 (A) WHETHER THE PROJECT PROPOSED TO BE FUNDED IS AUTHORIZED
- 22 BY THIS PART.
- 23 (B) WHETHER THE GRANT APPLICATION SUBMITTED COMPLIES WITH
- 24 THIS PART.
- 25 (C) WHETHER THE PROJECT IS CONSISTENT WITH THE WATERFRONT
- 26 REDEVELOPMENT PLAN FOR THE AREA IN WHICH THE PROJECT IS LOCATED.

- 1 (D) WHETHER THE PROJECT PROVIDES SIGNIFICANT PUBLIC ACCESS
- 2 TO THE WATERFRONT OR PROVIDES RECREATIONAL OPPORTUNITIES FOR THE
- 3 PUBLIC.
- 4 (E) WHETHER THE PROJECT WILL SIGNIFICANTLY CONTRIBUTE TO THE
- 5 LOCAL UNIT OF GOVERNMENT'S ECONOMIC AND COMMUNITY REDEVELOPMENT
- 6 OR THE REVITALIZATION OF ADJACENT NEIGHBORHOODS.
- 7 (F) WHETHER THERE IS EVIDENCE OF ADVERSE ECONOMIC AND SOCIO-
- 8 ECONOMIC CONDITIONS WITHIN THE WATERFRONT PLANNING AREA.
- 9 (G) THE VIABILITY OF THE WATERFRONT REDEVELOPMENT PLAN.
- 10 (H) WHETHER THE PROJECT IS INNOVATIVE IN COMPARISON TO OTHER
- 11 GRANT APPLICATIONS.
- 12 (I) THE LEVEL OF PUBLIC AND PRIVATE COMMITMENT AND OTHER
- 13 RESOURCES AVAILABLE FOR THE PROJECT.
- 14 (J) THE LEVEL OF PUBLIC AND PRIVATE COMMITMENT TO OTHER
- 15 ASPECTS OF THE WATERFRONT REDEVELOPMENT PLAN.
- 16 (K) HOW THE PROJECT RELATES TO A BROADER ECONOMIC AND COMMU-
- 17 NITY DEVELOPMENT PLAN FOR THE LOCAL UNIT OF GOVERNMENT AS A
- 18 WHOLE.
- 19 (1) THE LEVEL OF DEMONSTRATED COMMITMENT FROM OTHER GOVERN-
- 20 MENTAL AGENCIES.
- 21 (M) THE LEVEL OF PUBLIC AND PRIVATE COMMITMENT TO IMPROVING
- 22 ABANDONED REAL PROPERTY WITHIN THE WATERFRONT PLANNING AREA IN
- 23 WHICH THE PROJECT IS LOCATED.
- 24 (N) OTHER CRITERIA THAT THE DEPARTMENT AND THE COMMISSION
- 25 CONSIDER RELEVANT.
- 26 SEC. 79506. THE DEPARTMENT, WITH THE APPROVAL OF THE
- 27 COMMISSION, SHALL ISSUE GRANTS UNDER THIS PART FOR PROJECTS THAT

- 1 THE DEPARTMENT DETERMINES MEET THE REQUIREMENTS OF THIS PART AND
- 2 WILL CONTRIBUTE TO THE REVITALIZATION OF WATERFRONTS THROUGHOUT
- 3 THE STATE THAT ARE NOT BEING USED IN A MANNER THAT MAXIMIZES ECO-
- 4 NOMIC AND PUBLIC VALUE.

- 6 effect unless all of the following bills of the 89th Legislature
