HOUSE JOINT RESOLUTION GG

March 12, 1998, Introduced by Reps. Palamara, Profit, Emerson, Oxender, Quarles, Agee, Gubow, Wallace, Wojno, Hale, Ciaramitaro, Brewer and Voorhees and referred to the Committee on Appropriations.

A joint resolution proposing an amendment to the state constitution of 1963, by amending section 11 of article IX and adding section 40 to article IX, to provide for revenue sharing distributions to counties, cities, villages, and townships and to guarantee a certain annual increase in state aid to public schools.

Resolved by the Senate and House of Representatives of the state of Michigan, That the following amendment to the state constitution of 1963, to provide for revenue sharing distributions to counties, cities, villages, and townships and to guarantee a certain annual increase in state aid to public schools, is proposed, agreed to, and submitted to the people of the state:

1 ARTICLE IX

2 Sec. 11. There shall be established a state school aid fund 3 which shall be used exclusively for aid to school districts —, 4 higher education, and school employees' retirement systems, as 5 provided by law. Sixty percent of all taxes imposed at a rate of 6 4% on retailers on taxable sales at retail of tangible personal 7 property, 100% of the proceeds of the sales and use taxes imposed 8 at the additional rate of 2% provided for in section 8 of this 9 article, and other tax revenues provided by law, shall be dedi-10 cated to this fund. Payments from this fund shall be made in 11 full on a scheduled basis, as provided by law. 12 Beginning in the 1995-96 state fiscal year, and FOR each 13 state fiscal year -after FROM 1995-96 THROUGH 1998-1999, the 14 state shall quarantee that the total state and local per pupil 15 revenue for school operating purposes for each local school dis-16 trict shall not be less than the 1994-95 total state and local 17 per pupil revenue for school operating purposes for that local 18 school district, as adjusted for consolidations, annexations, or 19 other boundary changes. BEGINNING IN THE 1999-2000 STATE FISCAL 20 YEAR, AND FOR EACH STATE FISCAL YEAR AFTER 1999-2000, THE STATE 21 SHALL GUARANTEE THAT THE TOTAL STATE AND LOCAL PER PUPIL REVENUE 22 FOR SCHOOL OPERATING PURPOSES FOR EACH LOCAL SCHOOL DISTRICT 23 SHALL NOT BE LESS THAN THE 1997-1998 TOTAL STATE AND LOCAL PER 24 PUPIL REVENUE FOR SCHOOL OPERATING PURPOSES FOR THAT LOCAL SCHOOL 25 DISTRICT, AS ADJUSTED FOR CONSOLIDATIONS, ANNEXATIONS, OR OTHER
