- 2 funds from appropriations in part 1, or any enacted appropriation that
- 3 would [compete with] any Michigan private business or
- 4 enterprise, or could result in the loss of jobs in another community or
- 5 region of the state.

[Sec. 211. By March 1, 2000, the department of environmental quality shall submit to the senate and house of representatives appropriations committees and the standing committees of the senate and house of representatives with jurisdiction over issues primarily pertaining to natural resources and the environment, a plan for reporting on the expenditure of the proceeds of bonds issued under the clean Michigan initiative act, 1998 PA 284, MCL 324.95101 to 324.95108. The plan shall contain a proposal for preparation and distribution of reports to be issued beginning in 2003 and every 5 years thereafter until all bond proceeds have been expended and a final report that shall be issued within 1 year after all bond proceeds have been expended. (a) A cumulative update on the progress and accomplishments

attributable to the expenditure of bond proceeds.

(b) The amount of bonds sold.

(c) The amount of bond proceeds expended.

(d) The number of and locations of sites in which bond proceeds have been expended.

(e) The number of and locations of sites that have been redeveloped

with bond proceeds. (f) A summary of the data collected with bond proceeds.
(g) A summary of the overall effectiveness of bond proceed

expenditures.]

6 EXECUTIVE

- Sec. 301. The appropriation in part 1 for environmental education
- 8 curriculum shall be used to support educator training, education material
- 9 development, and distribution of environmental education curriculum
- 10 materials. The department shall work with the department of education
- 11 and a technical advisory committee to develop and distribute environmen-
- 12 tal education curriculum. The department shall not distribute materials
- 13 that duplicate materials currently used by middle school educators.

14 SURFACE WATER QUALITY

- 15 Sec. 401. The department shall monitor the quality of surface
- 16 waters located in state parks and recreation areas. Water quality sam-
- 17 ples shall be collected and analyzed on a weekly basis between May 1 and
- 18 September 30, 2000. Site or beach summaries shall be posted on the
- Internet and made available for general public use. 19
- 20 Sec. 402. The appropriation in part 1 for the volunteer river,
