- 1 SEC. 80. (1) THE TREASURER OF A COUNTY OR THE TREASURER OF
- 2 A HOME RULE CITY, WITH THE WRITTEN CONSENT OF THE TREASURER OF
- 3 THE COUNTY IN WHICH THE HOME RULE CITY IS LOCATED, MAY ACCEPT A
- 4 CONVEYANCE OF REAL PROPERTY FROM THE OWNER OF THAT REAL PROPERTY
- 5 TO SATISFY ALL OUTSTANDING TAXES OWED ON THAT REAL PROPERTY IF
- 6 ALL OF THE FOLLOWING CONDITIONS ARE SATISFIED:
- 7 (A) THE OWNER OR AN AFFILIATE OF THE OWNER OF THE REAL PROP-
- 8 ERTY HAS FILED AN ACTION UNDER TITLE 11 OF THE UNITED STATES
- 9 CODE, 11 U.S.C. 101 TO 1330, THAT HAS NOT BEEN DISMISSED,
- 10 WITHDRAWN, OR RESULTED IN AN ORDER OF DISCHARGE.
