- 1 LOCATION NOT READILY ACCESSIBLE TO THE OPERATOR OR PASSENGERS OF

- 3 (b) The bow or crossbow is unstrung, enclosed in a case,
- 4 or AND carried in the trunk of a vehicle OR IF THE VEHICLE DOES
- 5 NOT HAVE A TRUNK, IN A LOCATION NOT READILY ACCESSIBLE TO THE
