- 2 ACT, THE COURT MAY ORDER AN INDIVIDUAL CONVICTED OF COMMITTING A
- 3 VIOLATION OF THIS ACT IN WHICH AN INDIVIDUAL 65 YEARS OF AGE OR
- 4 OLDER IS A VICTIM OF THAT VIOLATION TO PAY NOT MORE THAN TWICE
- 5 THE FINE OTHERWISE AUTHORIZED FOR THAT VIOLATION OR TO PAY A FINE
- 6 AUTHORIZED UNDER SUBSECTION (2).
- 7 (2) IF THE VIOLATION IS NOT OTHERWISE PUNISHABLE BY A FINE,
- 8 THE COURT, IN ADDITION TO ANY AUTHORIZED PENALTY, MAY ORDER THE
- 9 INDIVIDUAL TO PAY A FINE AS FOLLOWS:
- 10 (A) A FINE OF NOT MORE THAN \$200.00 IF THE VIOLATION IS A
- 11 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR LESS THAN 6 MONTHS.

- 11 MORE THAN 4 YEARS.
- (F) A FINE OF NOT MORE THAN \$5,000.00 IF THE VIOLATION IS A 12
- 13 FELONY PUNISHABLE BY IMPRISONMENT FOR 5 YEARS.
- (G) A FINE OF NOT MORE THAN \$10,000.00 IF THE VIOLATION IS A 14
- 15 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 5 YEARS.
- 16 (3) THIS SECTION APPLIES TO CRIMES COMMITTED ON OR AFTER THE
- 17 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
