SENATE SUBSTITUTE FOR HOUSE BILL NO. 4018

A bill to amend 1917 PA 138, entitled

"An act to authorize the creation of county libraries; to authorize the contracting by the board of supervisors of any county for library service; to authorize the contracting by the board of supervisors of any county or the board of trustees of any regional library with any other municipality for the furnishing of such service; and to provide for a tax for the purposes of this act,"

by amending section 2 (MCL 397.302), as amended by 1994 PA 77.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. (1) To administer the county library fund, there
- 2 shall be a library board consisting of 5 members appointed by the

- 4 that the first members shall be appointed for 1, 2, 3, 4, and 5
- 5 years. In a county with a population of over 1,000,000, the

- 7 county, or, in a county with a population of over 1,500,000, his
- 8 or her designee, shall be 1 of the members of the library board
