- 2 ADOPT-A-FOREST PROGRAM
- 3 SEC. 36001. AS USED IN THIS PART:
- 4 (A) "PARTICIPANT" MEANS A VOLUNTEER GROUP OR INDIVIDUAL PAR-
- 5 TICIPATING IN THE ADOPT-A-FOREST PROGRAM.
- 6 (B) "WASTES" INCLUDES SOLID WASTE AS DEFINED IN PART 115,
- 7 HAZARDOUS WASTE AS DEFINED IN PART 111, AND OTHER RECYCLABLE
- 8 MATERIALS.
- 9 SEC. 36002. (1) THE DEPARTMENT SHALL ADMINISTER A PROGRAM
- 10 ENTITLED THE ADOPT-A-FOREST PROGRAM, WHICH SHALL BE DESIGNED TO
- 11 REMOVE ILLEGALLY DUMPED WASTE FROM PUBLIC FORESTLANDS. THE

- 7 PRIATIONS SUBCOMMITTEES ON NATURAL RESOURCES. THIS ANNUAL REPORT
- 8 SHALL INCLUDE THE NUMBER OF ACRES FROM WHICH WASTES WERE REMOVED,
- 9 THE NUMBER OF TONS OF WASTES REMOVED, AND THE AMOUNT OF WASTES
- 10 THAT WERE RECYCLED.
