A bill to amend 1978 PA 361, entitled "Michigan exposition and fairgrounds act," by amending sections 2, 5, 6, 7, 8, 9, and 11 (MCL 285.162, 285.165, 285.166, 285.167, 285.168, 285.169, and 285.171) and by adding sections 14a and 15a; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Council" means the state exposition and fairgrounds
- 3 council created in section 9.
- 4 (b) "Department" means the state department of natural
- 5 resources AGRICULTURE.
- 6 (c) "Director" means the director of the department.
- 7 (D) "FUND" MEANS THE STATE EXPOSITION AND FAIRGROUNDS FUND
- 8 CREATED IN SECTION 14A.

- 1 (E) $\overline{(d)}$ "Manager" means the manager of the state
- 2 exposition and fairgrounds.
- 3 Sec. 5. The control of all land and other property vested

- 4 in HELD OR ACQUIRED BY the state or its people for the purpose
- 5 of holding and conducting agricultural and industrial fairs and
- 6 exhibitions -, is transferred from the department of agricul-
- 7 ture and vested in the department.
- 8 Sec. 6. The department shall DO ALL OF THE FOLLOWING:
- 9 (a) Conduct an annual state fair and other exhibits or
- 10 events for the purpose of promoting all phases of the economy of
- 11 this state. This fair and THE exhibits or events shall encourage

- 20 LAND, A BUILDING, OR OTHER PROPERTY THAT IS LEASED UNDER THIS
- 21 SUBDIVISION TO A FOR-PROFIT BUSINESS SHALL BE LEASED AT FAIR
- 22 MARKET VALUE. ALL LEASES AND CONTRACTS ENTERED INTO UNDER THIS
- 23 ACT REMAIN VALID UNTIL THE EXPIRATION OF THE TERM OF THE LEASE OR
- 24 CONTRACT.
- 25 (c) Enter into contracts to conduct the annual state fair,
- 26 exhibits, or other events, at the fair and STATE exposition
- 27 grounds which shall AND FAIRGROUNDS THAT enhance agricultural,

- 3 Sec. 7. (1) The department annually shall present a report
- 4 to the governor, THE legislature, and THE council describing the
- 5 condition of receipts and disbursements of the state fair
- 6 revolving fund and any other receipts or expenditures through
- 7 appropriation, gift, grant, or conveyance which has THAT HAVE a
- 8 material bearing on the operation of the state fair or THE STATE
- 9 EXPOSITION AND fairgrounds.
- 10 (2) An annual audit of the books and records of the state
- 11 exposition and fairgrounds shall be made by the auditor general.
- 12 (3) The department shall prepare or cause to be prepared an

1 Sec. 9. (1) A state exposition and fairgrounds council is

- 25 as appropriate.

- 14 FUND. THE STATE TREASURER SHALL CREDIT TO THE FUND INTEREST AND
- 15 EARNINGS FROM FUND INVESTMENTS. THE STATE TREASURER MAY RECEIVE

- (5) UPON APPROPRIATION, MONEY IN THE FUND SHALL BE EXPENDED
