(As passed the House, May 30, 2000)

A bill to amend 1939 PA 288, entitled "Probate code of 1939,"

(MCL 710.21 to 712A.32) by adding chapter XII; and to repeal acts and parts of acts.

- 3 SEC. 20. (1) THE DEPARTMENT OF COMMUNITY HEALTH IN CONJUNC-
- 4 TION WITH THE DEPARTMENT SHALL ESTABLISH A SAFE DELIVERY
- 5 PROGRAM. THE SAFE DELIVERY PROGRAM SHALL INCLUDE, BUT IS NOT
- 6 LIMITED TO, BOTH OF THE FOLLOWING:
- 7 (A) A TOLL-FREE, 24-HOUR TELEPHONE LINE. THE INFORMATION
- 8 PROVIDED WITH THIS TELEPHONE LINE SHALL INCLUDE, BUT IS NOT
- 9 LIMITED TO, ALL OF THE FOLLOWING:
