HOUSE BILL NO. 5690

(As passed the House, May 18, 2000)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding sections 32610 and 32611.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 32610. (1) THE SUBMERGED LOG RECOVERY FUND IS CREATED
- 2 WITHIN THE STATE TREASURY.
- 3 (2) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
- 4 FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER
- 5 SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER
- 6 SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
- 7 INVESTMENTS.
- 8 (3) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 9 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 10 (4) SUBJECT TO SUBSECTION (5), MONEY FROM THE FUND SHALL BE
- 11 USED, UPON APPROPRIATION, FOR THE ADMINISTRATIVE COSTS OF THE

- 23 INCLUDING. BUT NOT LIMITED TO, THE PREVENTION AND MANAGEMENT OF NON-NATIVE SPECIES, COASTAL WETLAND RESTORATION, CON-
- 24 TAMINATED SEDIMENT CLEANUP, AND UNDERWATER PRESERVE MANAGEMENT.
