

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 539

A bill to amend 1846 RS 16, entitled
"Of the powers and duties of townships, the election and duties
of township officers, and the division of townships,"
by amending section 110b (MCL 41.110b), as added by 1989 PA 77.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 110b. (1) A township may do all of the following:
- 2 (a) Establish a retirement system for its employees and pro-
- 3 vide for financing, funding, and the payment of benefits in the
- 4 same manner and to the same extent as permitted counties under
- 5 section 12a of ~~Act No. 156 of the Public Acts of 1851, being~~
- 6 ~~section 46.12a of the Michigan Compiled Laws~~ 1851 PA 156, MCL
- 7 46.12A, or make contracts of insurance with an insurance company
- 8 authorized to transact business within ~~the~~ THIS state.
- 9 (b) Make arrangements with a prepayment plan authorized to

16 (C) ESTABLISH A CAFETERIA PLAN AUTHORIZED UNDER SECTION 125
17 OF THE INTERNAL REVENUE CODE OF 1986 FOR ITS ELECTED OR APPOINTED
18 OFFICERS AND EMPLOYEES, ANY CLASSES OF ELECTED OR APPOINTED OFFI-
19 CERS AND EMPLOYEES, AND DEPENDENTS OF THOSE OFFICERS AND THOSE
20 EMPLOYEES. AS USED IN THIS SUBDIVISION, "CAFETERIA PLAN" MEANS
21 THAT TERM AS DEFINED IN SECTION 125 OF THE INTERNAL REVENUE CODE
22 OF 1986.

23 (D) ~~(c)~~ Contract with a company that grants annuities or
24 pensions for the pensioning of the officers and employees and for
25 these purposes pay any part of the premiums or charges for insur-

1 (E) OFFER ANY OTHER EMPLOYMENT BENEFIT AUTHORIZED BY STATE
2 OR FEDERAL LAW.

3 (2) Notwithstanding any other provision of law, the proper
4 disbursing officer of the township may deduct from an officer's
5 or employee's pay, salary, or compensation that part of the pre-
6 mium or charge ~~as~~ THAT is payable by the officer or employee.

7 (3) A contract of insurance or arrangement for prepayment
8 plan coverage procured ~~pursuant to~~ UNDER this section may pro-
9 vide that each elected or appointed officer or employee becoming
10 eligible for insurance or coverage becomes insured or covered
11 automatically when he or she becomes eligible, subject to any
12 actively-at-work requirements OR EFFECTIVE RETIREMENT DATES spec-
13 ified in the contract or arrangement. If the insurance or cover-
14 age under the contract or arrangement requires contributions from
15 the individual, any individual desiring not to be ~~so~~ insured or
16 covered UNDER THE CONTRACT OR ARRANGEMENT shall give written
17 notice to his or her employing office that he or she desires not
18 to be insured or covered, and if the notice is received before
19 the individual has become insured or covered under the contract
20 or arrangement, he or she shall not be insured or covered. If
21 the notice is received after the individual has become insured or
22 covered, his or her insurance or coverage under the contract or
23 arrangement shall cease as provided for in the contract or
24 arrangement.

25 (4) This section does not affect the validity of a retire-
26 ment program or contract of group insurance or arrangement for
27 prepayment plan coverage entered into by the township before ~~the~~

3 (5) The authority given under this section is in addition to
4 and not in derogation of any power existing in the township under
5 the laws of this state. A township may exercise the powers
6 granted under this section by ordinance without THE necessity of
7 amending its charter.
