**SUBSTITUTE FOR  
SENATE BILL NO. 784**

(As Passed the Senate October 20, 1999)

A bill to amend 1956 PA 218, entitled  
"The insurance code of 1956,"  
by amending section 5104 (MCL 500.5104), as added by 1993 PA  
200.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 5104. (1) Subject to the requirements of this act  
2 applicable to domestic stock insurers, domestic mutual insurers,  
3 reciprocals or inter-insurance exchanges, and the further  
4 requirements of this chapter, 13 or more persons may organize a  
5 stock insurer or 20 or more persons may organize a mutual insurer  
6 for the purpose of transacting any or all of the following kinds  
7 of insurance: property, marine, inland navigation and transpor-  
8 tation, casualty, or fidelity and surety, all as defined in  
9 chapter 6. Once organized and authorized, the acquiring insurer  
10 ~~shall be~~ IS subject to all applicable provisions of this act.

8 only transact worker's compensation insurance and employer's  
9 liability insurance, TRANSACT DISABILITY INSURANCE LIMITED TO  
10 REPLACEMENT OF LOSS OF EARNINGS, and act as an administrative  
11 services organization for an approved self-insured worker's com-  
12 pensation plan OR A DISABILITY INSURANCE PLAN LIMITED TO REPLACE-  
13 MENT OF LOSS OF EARNINGS. THIS SUBSECTION DOES NOT PRECLUDE THE  
14 ACQUIRING INSURER FROM PROVIDING EITHER DIRECTLY OR INDIRECTLY  
15 NONINSURANCE PRODUCTS AND SERVICES AS OTHERWISE PROVIDED BY LAW.

16       Enacting section 1. This amendatory act does not take  
17 effect unless Senate Bill No. 783 of the 90th Legislature is  
18 enacted into law.
