

Senate Bill No. 827

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811j.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811J. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
2 SECTION 811E AND, UPON APPLICATION, MAY ISSUE UNDER SECTION 811F
3 A STATE-SPONSORED CHILDREN'S TRUST FUND-RAISING REGISTRATION
4 PLATE AND A MATCHING STATE-SPONSORED CHILDREN'S TRUST COLLECTOR
5 PLATE AS PROVIDED UNDER SECTION 811G. THE PLATE SHALL BE OF A
6 DESIGN AS DETERMINED BY THE SECRETARY OF STATE AFTER CONSULTATION
7 WITH THE STATE CHILD ABUSE AND NEGLECT PREVENTION BOARD CREATED
8 IN SECTION 3 OF THE CHILD ABUSE AND NEGLECT PREVENTION ACT, 1982
9 PA 250, MCL 722.603.

10 (2) CHILDREN'S TRUST FUND-RAISING REGISTRATION PLATE
11 DONATIONS COLLECTED UNDER SECTION 811F AND MATCHING CHILDREN'S

1 TRUST COLLECTOR PLATE FUND-RAISING DONATIONS COLLECTED UNDER
2 SECTION 811G SHALL BE TRANSFERRED UNDER SECTION 811H BY THE SEC-
3 RETARY OF STATE TO THE STATE TREASURER, WHO SHALL CREDIT THE
4 DONATION MONEY TO THE CHILDREN'S TRUST FUND CREATED UNDER
5 SECTION 1 OF 1982 PA 249, MCL 21.171, FOR THE SUPPORT AND BENEFIT
6 OF THE CHILDREN OF THIS STATE.

7 (3) FOR PURPOSES OF THIS CHAPTER, "STATE-SPONSORED
8 CHILDREN'S TRUST FUND-RAISING REGISTRATION PLATE" MEANS A REGIS-
9 TRATION PLATE CONTAINING A SPECIALIZED DESIGN PERTAINING TO THE
10 CHILDREN OF THIS STATE.

11 Enacting section 1. This amendatory act takes effect
12 October 1, 2000.

13 Enacting section 2. This amendatory act does not take
14 effect unless all of the following bills of the 90th Legislature
15 are enacted into law:
