- 3 INTENT TO USE THAT INFORMATION FOR ANY OF THE FOLLOWING PURPOSES
- 4 WITHOUT THAT PERSON'S AUTHORIZATION:
- 5 (A) TO OBTAIN FINANCIAL CREDIT.
- 6 (B) TO PURCHASE OR OTHERWISE OBTAIN OR LEASE ANY REAL OR
- 7 PERSONAL PROPERTY.
- 8 (C) TO OBTAIN EMPLOYMENT.
- 9 (D) TO OBTAIN ACCESS TO MEDICAL RECORDS OR INFORMATION
- 10 CONTAINED IN MEDICAL RECORDS.

- 15 ENTRIES, AND X-RAYS AND OTHER IMAGING RECORDS.
- 16 (C) "PERSONAL IDENTITY INFORMATION" MEANS ANY OF THE FOLLOW-
- 17 ING INFORMATION OF ANOTHER PERSON:
- 18 (i) A SOCIAL SECURITY NUMBER.
- 19 (ii) A DRIVER LICENSE NUMBER OR STATE PERSONAL IDENTIFICA-
- 20 TION CARD NUMBER.
- 21 (iii) EMPLOYMENT INFORMATION.
- 22 (iv) INFORMATION REGARDING ANY FINANCIAL ACCOUNT HELD BY
- 23 ANOTHER PERSON INCLUDING, BUT NOT LIMITED TO, ANY OF THE
- 24 FOLLOWING:
- 25 (A) A SAVINGS OR CHECKING ACCOUNT NUMBER.
- 26 (B) A FINANCIAL TRANSACTION DEVICE ACCOUNT NUMBER.
