## SUBSTITUTE FOR SENATE BILL NO. 936

(As Passed the Senate February 17, 2000)

A bill to amend 1982 PA 455, entitled "The library privacy act," by amending section 6 (MCL 397.606), as added by 1999 PA 37.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) If a library offers use of the internet or a
- 2 computer, computer program, computer network, or computer system
- 3 to the public, the governing body of that library may authorize
- 4 or may require that the library restrict SHALL ADOPT AND REQUIRE
- 5 ENFORCEMENT OF A POLICY THAT RESTRICTS access to minors by pro-

- 7 computer network, or computer system in 1 OF the following

- (i)  $\overline{(a)}$  By making available, to individuals of any age, 1
