23 district judge of the eighty-sixth district is a candidate for
24 the office of judge, the candidate for judgeship of the
25 eighty-sixth district receiving the highest number of votes in
26 the 2000 general election shall be elected for a term of 6 years
27 and the candidate for judgeship of the eighty-sixth district

1 receiving the second highest number of votes shall be elected for
2 a term of 4 years for that election only.

3 (b) If 1 incumbent district judge of the eighty-sixth dis-
4 trict is a candidate for the office of judge, the candidate
5 receiving the highest number of votes for the judgeship for which
6 the incumbent judge is seeking election shall be elected for a
7 term of 6 years, and the candidate receiving the highest number
8 of votes for the judgeship for which the incumbent judge is not
9 seeking election shall be elected for a term of 4 years.
