"The code of criminal procedure,"
(MCL 760.1 to 777.69) by adding section 2b to chapter IV.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 SEC. 2B. (1) A LAW ENFORCEMENT OFFICER OF AN ADJACENT STATE
- 3 HAS THE SAME AUTHORITY AND IMMUNITY AS A LAW ENFORCEMENT OFFICER
- 4 OF THIS STATE AS PROVIDED BY LAW IF ALL OF THE FOLLOWING CONDI-
- 5 TIONS ARE MET:
- 6 (A) THE LAW ENFORCEMENT OFFICER IS AUTHORIZED TO ARREST A
- 7 PERSON, WITH OR WITHOUT A WARRANT, FOR A VIOLATION OF A PENAL
- 8 STATUTE OR LAW IN THE ADJACENT STATE.
- 9 (B) THE LAW ENFORCEMENT OFFICER IS ON DUTY AS A LAW
- 10 ENFORCEMENT OFFICER IN THE ADJACENT STATE.

- (B) "EMERGENCY" MEANS A SUDDEN OR UNEXPECTED CIRCUMSTANCE
- 17 THAT REQUIRES IMMEDIATE ACTION TO PROTECT THE HEALTH, SAFETY,
- 18 WELFARE, OR PROPERTY OF AN INDIVIDUAL FROM ACTUAL OR THREATENED
- 19 HARM OR FROM AN UNLAWFUL ACT.
