

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 1275

(As amended June 8, 2000)

A bill to amend 1984 PA 431, entitled
"The management and budget act,"
by amending section 358 (MCL 18.1358).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 358. (1) ~~The~~ EXCEPT AS OTHERWISE PROVIDED IN [THIS
2 SECTION], THE legislature may make an emergency appropriation
3 from the fund subject to all of the following conditions:
4 (a) The maximum appropriation from the fund for budget sta-
5 bilization as provided in section 352(2) has already been made
6 for the current fiscal year.
7 (b) The legislature has approved the emergency appropria-
8 tions bill by a 2/3 majority vote of the members elected to and
9 serving in each house.
10 (c) The emergency appropriations bill becomes law.

1 (2) The additional transfer from the fund may be made only
2 for the current fiscal year.

3 (3) FOR EACH FISCAL YEAR, BEGINNING WITH THE FISCAL YEAR

5 SEPTEMBER 30, 2016, THERE IS APPROPRIATED AND TRANSFERRED FROM
6 THE FUND TO THE STATE TRUNK LINE FUND ESTABLISHED UNDER

8 \$35,000,000.00.

11 LINE FUND ESTABLISHED UNDER SECTION 11 OF 1951 PA 51,
12 MCL 247.661, THE SUM OF \$37,100,000.00.

13 (5) FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2000, AN AMOUNT
14 EQUAL TO THE UNRESERVED GENERAL FUND GENERAL PURPOSE BALANCE
15 TRANSFERRED TO THE FUND FOR THE FISCAL YEAR ENDING SEPTEMBER 30,
16 2000, BUT NOT TO EXCEED \$62,900,000.00, IS APPROPRIATED AND
17 TRANSFERRED FROM THE FUND TO THE STATE TRUNK LINE FUND ESTAB-
18 LISHED UNDER SECTION 11 OF 1951 PA 51, MCL 247.661.
