16 (2) FOR A VIOLATION OF SECTION 145D OF THE MICHIGAN PENAL
17 CODE, 1931 PA 328, MCL 750.145D, DETERMINE THE OFFENSE CATEGORY,
18 OFFENSE VARIABLE LEVEL, AND PRIOR RECORD VARIABLE BASED ON THE
19 UNDERLYING OFFENSE.

20 Enacting section 1. This amendatory act takes effect 90
21 days after the date it is enacted.

22 Enacting section 2. This amendatory act does not take
23 effect unless Senate Bill No. 894 of the 90th Legislature is
24 enacted into law.
