A bill to amend 1993 PA 23, entitled "Michigan limited liability company act," by amending section 904 (MCL 450.4904), as amended by 1997 PA 123.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 904. (1) Except as otherwise provided in this section
- 2 or otherwise prohibited, a professional limited liability company
- 3 may render 1 or more professional services, and each member and
- 4 manager shall be a licensed person in 1 or more of the profes-
- 5 sional services rendered by the company.
- 6 (2) If the professional limited liability company renders a
- 7 professional service that is included within the public health
- 8 code, 1978 PA 368, MCL 333.1101 to 333.25211, then all members
- 9 and managers of the company shall be licensed or legally

- 1 authorized in this state to render the same professional
  2 service.
- 3 (3) A licensed person of another jurisdiction may become a
- 4 member, manager, employee, or agent of the professional limited
- 5 liability company, but shall not render any professional services

- **8** (4) A limited liability company may engage in the practice
