## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 92A. HEPATITIS A OUTBREAKS
- 2 SEC. 9231. (1) IF THE DIRECTOR DETERMINES THAT THERE IS A
- 3 HEPATITIS A OUTBREAK IN A COMMUNITY THAT WARRANTS TARGETED OR
- 4 WIDESPREAD VACCINATION FOR HEPATITIS A, THE DIRECTOR SHALL PRO-
- 5 CEED PURSUANT TO THIS PART. THE DIRECTOR SHALL MAKE AVAILABLE TO
- 6 THE LOCAL HEALTH DEPARTMENT WITH JURISDICTION IN THAT COMMUNITY A
- 7 SUFFICIENT AMOUNT OF HEPATITIS A VACCINE OR ANY OTHER VACCINE
- 8 RECOMMENDED BY THE FEDERAL CENTERS FOR DISEASE CONTROL AND PRE-
- 9 VENTION, PENDING THE RECEIPT OR COMMITMENT OF FUNDING FROM THE
- 10 FEDERAL CENTERS FOR DISEASE CONTROL AND PREVENTION.
