A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 222 (MCL 257.222), as amended by 1993 PA 300.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 222. (1) Except as otherwise provided in this act, the
- 2 secretary of state shall issue a registration certificate and a
- 3 certificate of title when registering a vehicle and upon receipt
- 4 of the required fees. A vehicle brought into this state from
- 5 another state or jurisdiction that has a rebuilt, salvage, or
- 6 scrap certificate of title issued by that other state or juris-
- 7 diction shall be issued a rebuilt, salvage, or scrap certificate
- 8 of title by the secretary of state.
- **9** (2) The registration certificate shall be delivered to the
- 10 owner and shall contain on its face the date issued, the name and

- 1 address of the owner, the registration number assigned to the
- 2 vehicle, and a description of the vehicle as determined by the
- 3 secretary of state.
- 4 (3) The certificate of title shall be manufactured in a
- 5 manner to prohibit as nearly as possible the ability to repro-
- 6 duce, alter, counterfeit, forge, or duplicate the certificate of
- 7 title without ready detection and contain on its face the ALL
- 8 OF THE FOLLOWING:
- 9 (A) THE identical information required on the face of the
- 10 registration certificate. -; if
- 11 (B) IF the vehicle is a motor vehicle, the number of miles,
- 12 not including the tenths of a mile, registered on the vehicle's
- 13 odometer at the time of transfer. -; except for a vehicle owned
- 14 by a dealer and loaned to a political subdivision of this state
- 15 for use as a driver education vehicle , if
- 16 (C) If the vehicle is to be used or has been used as a taxi,
- 17 as a police vehicle, or by a political subdivision of this state,
- 18 -; whether EXCEPT FOR A VEHICLE OWNED BY A DEALER AND LOANED TO
- 19 A POLITICAL SUBDIVISION OF THIS STATE FOR USE AS A DRIVER EDUCA-
- 20 TION VEHICLE.
- 21 (D) WHETHER the vehicle is a salvage vehicle. ; if
- 22 (E) IF the vehicle has previously been issued a rebuilt cer-
- 23 tificate of title from this state or a comparable certificate of
- 24 title from any other ANOTHER state or jurisdiction. -; if
- 25 (F) IF the vehicle has been issued a scrap certificate of
- 26 title from this state or a comparable certificate of title from
- 27 any other ANOTHER state or jurisdiction. ; a

- 1 (G) A statement of the owner's title and of all security
- 2 interests in the vehicle or in an accessory on the vehicle as set
- 3 forth in the application. ; the
- 4 (H) THE date that the application was filed. -; and any
- 5 (I) ANY other information that the secretary of state may 6 require.
- 7 (J) A SEAL. AS USED IN THIS SUBDIVISION, "SEAL" MEANS A
- 8 DISTINGUISHING SEAL THAT IS DEVELOPED BY THE SECRETARY OF STATE,
- 9 THAT IS DIFFICULT TO DUPLICATE, AND THAT WILL AID IN THE PREVEN-
- 10 TION OF FRAUD.
- 11 (4) The EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,
- 12 THE certificate of title shall -contain, upon the reverse side,
- 13 BE IN A 2-PART FORM THAT IS DESIGNED BY THE SECRETARY OF STATE
- 14 AND THAT CONTAINS a form for assignment of title or interest and
- 15 warranty of title by the owner with space for the notation of a
- 16 security interest in the vehicle and in an accessory on the vehi-
- 17 cle, that at the time of a transfer shall be certified and
- 18 signed, and space for a written odometer mileage statement that
- 19 is required upon transfer pursuant to section 233a. THE 2-PART
- 20 FORM SHALL CONSIST OF 1 PART THAT THE BUYER EXECUTES TO TRANSFER
- 21 TITLE AND 1 PART THAT THE SELLER FILES WITH THE SECRETARY OF
- 22 STATE OR RETAINS FOR PROOF OF SALE. The reverse side of the
- 23 certificate of title may also contain other forms that the secre-
- 24 tary of state considers necessary to facilitate the effective
- 25 administration of this act. The certificate shall bear the coat
- 26 of arms of this state.

- 1 (5) The certificate of title shall be mailed or delivered to
- 2 the owner or other person the owner may direct in a separate
- 3 instrument, in a form the secretary of state shall prescribe.
- 4 (6) A person who intentionally reproduces, alters, counter-
- 5 feits, forges, or duplicates a certificate of title or who uses a
- 6 reproduced, altered, counterfeited, forged, or duplicated certif-
- 7 icate of title shall be punished as follows:
- 8 (a) If the intent of reproduction, alteration, counterfeit-
- 9 ing, forging, duplication, or use was to commit or aid in the
- 10 commission of an offense punishable by imprisonment for 1 or more
- 11 years, the person committing the reproduction, alteration, coun-
- 12 terfeiting, forging, duplication, or use is guilty of a misde-
- 13 meanor, punishable by imprisonment for a period equal to that
- 14 which could be imposed for the commission of the offense the
- 15 person had the intent to aid or commit. The court may also
- 16 assess a fine of not more than \$10,000.00 against the person.
- 17 (b) If the intent of the reproduction, alteration, counter-
- 18 feiting, forging, duplication, or use was to commit or aid in the
- 19 commission of an offense punishable by imprisonment for not more
- 20 than 1 year, the person committing the reproduction, alteration,
- 21 counterfeiting, forging, duplication, or use is guilty of a mis-
- 22 demeanor, punishable by imprisonment for not more than 1 year, or
- 23 a fine of not more than \$1,000.00, or both.
- 24 (7) The certificate of title for a police vehicle, a vehicle
- 25 owned by a political subdivision of this state, a salvage vehi-
- 26 cle, a rebuilt vehicle, and a scrap vehicle shall be different in
- 27 color from the certificate of title for all other vehicles.

- 1 (8) A scrap certificate of title shall contain a legend that
- 2 the vehicle is not to be titled or registered and is to be used
- 3 for parts or scrap metal only.
- 4 (9) A certificate of title shall not be issued for a vehicle
- 5 which THAT has had a salvage certificate of title unless the
- 6 certificate of title contains a legend -which THAT would dis-
- 7 close the vehicle's former condition to consumers and potential
- 8 purchasers.
