A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 6.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 6 DEPARTMENT OF ENVIRONMENTAL QUALITY
- 2 SEC. 601. (1) THE DEPARTMENT OF ENVIRONMENTAL QUALITY CRE-
- 3 ATED UNDER EXECUTIVE REORGANIZATION ORDER NO. 1995-16 SHALL POS-
- 4 SESS THE POWERS AND PERFORM THE DUTIES GRANTED AND IMPOSED BY
- 5 THIS ACT AND AS OTHERWISE PROVIDED BY LAW.
- 6 (2) THE ENVIRONMENTAL QUALITY COMMISSION IS CREATED AS THE
- 7 HEAD OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY AND SHALL ESTAB-
- 8 LISH GENERAL POLICIES RELATED TO NATURAL RESOURCES MANAGEMENT AND
- 9 ENVIRONMENTAL PROTECTION FOR THE GUIDANCE OF THE DIRECTOR OF THE
- 10 DEPARTMENT OF ENVIRONMENTAL QUALITY IN ADMINISTERING HIS OR HER

- 1 PROVIDED BY LAW, AND SHALL HAVE APPELLATE POWERS AS ESTABLISHED
- 2 IN SECTION 602. THE ENVIRONMENTAL QUALITY COMMISSION SHALL BE
- 3 COMPOSED OF 7 MEMBERS, NOT MORE THAN 4 OF WHOM SHALL BE MEMBERS
- 4 OF THE SAME POLITICAL PARTY, APPOINTED BY THE GOVERNOR BY AND

- 5 INGS ACT, 1976 PA 267, MCL 15.261 TO 15.275. A MEETING MAY BE
- 6 CALLED BY THE CHAIRPERSON AND SHALL BE CALLED ON REQUEST OF A
- 7 MAJORITY OF THE MEMBERS OF THE ENVIRONMENTAL QUALITY COMMISSION.
- 8 MEETINGS MAY BE HELD AS OFTEN AS NECESSARY AND AT OTHER PLACES

- 27 QUALITY IS UNABLE TO PERFORM THE DUTIES OF THAT OFFICE OR IS

- 1 ABSENT FROM THE STATE, THE POWERS AND DUTIES OF THE DIRECTOR OF
- 2 THE DEPARTMENT OF ENVIRONMENTAL QUALITY AS PRESCRIBED BY LAW
- 3 SHALL BE IMPOSED ON AND TRANSFERRED TO A DEPUTY DIRECTOR UNTIL
- 4 THE VACANCY IS FILLED OR THE INABILITY OR ABSENCE FROM THE STATE
- 5 OF THE DIRECTOR OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY
- 6 CEASES.
- 7 (5) THE COMPENSATION OF THE DEPUTY DIRECTORS, THE ASSIST-
- 8 ANTS, AND THE EMPLOYEES AND THE NUMBER OF ASSISTANTS AND EMPLOY-
- 9 EES SHALL BE SUBJECT TO THE APPROVAL OF THE STATE ADMINISTRATIVE
- 10 BOARD. THE MEMBERS OF THE ENVIRONMENTAL QUALITY COMMISSION SHALL
- 11 NOT RECEIVE COMPENSATION UNDER THIS PART, BUT EACH MEMBER AND THE
- 12 OTHER OFFICERS AND EMPLOYEES OF THE DEPARTMENT OF ENVIRONMENTAL
- 13 QUALITY ARE ENTITLED TO REASONABLE EXPENSES WHILE TRAVELING IN
- 14 THE PERFORMANCE OF THEIR DUTIES PRESCRIBED BY THIS ACT AND AS
- 15 OTHERWISE PROVIDED BY LAW. THE SALARIES AND EXPENSES AUTHORIZED
- 16 UNDER THIS ACT SHALL BE PAID OUT OF THE STATE TREASURY IN THE
- 17 SAME MANNER AS THE SALARIES OF OTHER STATE OFFICERS AND EMPLOYEES
- 18 ARE PAID. THE DEPARTMENT OF MANAGEMENT AND BUDGET SHALL FURNISH
- 19 SUITABLE OFFICES AND OFFICE EQUIPMENT, AT LANSING, FOR THE USE OF
- 20 THE DEPARTMENT OF ENVIRONMENTAL QUALITY. EACH MEMBER OF THE
- 21 ENVIRONMENTAL QUALITY COMMISSION AND THE DIRECTOR OF THE DEPART-

- 27 WORKING DAYS HAVE PASSED FOLLOWING THE PROVISIONAL ISSUANCE OF A

- 1 PERMIT. DURING THE 10 DAYS FOLLOWING THE PROVISIONAL PERMIT
- 2 ISSUANCE, ANY PERSON MAY PETITION THE ENVIRONMENTAL QUALITY COM-
- 3 MISSION TO HEAR AN APPEAL OF THE PROPOSED PERMITTING DECISION.
- 4 THE ENVIRONMENTAL QUALITY COMMISSION SHALL HEAR THE APPEAL UNLESS
- 5 THE COMMISSION FINDS THAT THE APPEAL IS FRIVOLOUS AND WHOLLY
- 6 WITHOUT MERIT BASED ON PERTINENT PROVISIONS OF THIS ACT AND RULES
- 7 PROMULGATED UNDER THIS ACT. THE REJECTION OF AN APPEAL SHALL BE
- 8 MADE IN WRITING TO THE APPLICANT.
- **9** (2) THE ENVIRONMENTAL QUALITY COMMISSION SHALL REQUEST THAT
- 10 AFFECTED PARTIES AND PERSONS WHO HAVE PETITIONED FOR AN APPEAL
- 11 SUBMIT WRITTEN DOCUMENTATION AND BRIEFS WITH RESPECT TO THE
- 12 APPEALS. A PUBLIC HEARING SHALL BE CONDUCTED, AND FOLLOWING A
- 13 VOTE ON THE MERITS OF THE PERMIT ISSUE AT A PUBLIC MEETING, THE
- 14 ENVIRONMENTAL QUALITY COMMISSION SHALL PROVIDE THE PARTIES WITH A
- 15 WRITTEN OPINION AND DECISION WITHIN 90 DAYS OF AGREEING TO HEAR
- 16 AN APPEAL.
- 17 (3) A MEMBER OF THE ENVIRONMENTAL QUALITY COMMISSION SHALL
- 18 NOT PARTICIPATE IN AN APPEAL IN WHICH THE MEMBER HAS A FINANCIAL
- 19 OR PERSONAL INTEREST.
- 20 (4) THE DECISION OF THE ENVIRONMENTAL QUALITY COMMISSION TO
- 21 NOT HEAR AN APPEAL MAY BE APPEALED TO THE COURTS AS PROVIDED BY
- 22 LAW. A DECISION BY THE ENVIRONMENTAL QUALITY COMMISSION TO HEAR
- 23 AN APPEAL IS FINAL AND IS NOT APPEALABLE.
